A. CALL TO ORDER

C. ORGANIZATION OF BOARD

1. Election of Chairperson

Nominations were called for the position of Spring Lake Park Schools School Board Chairperson. Easter was nominated by Hennen. No further nominations were made. By acclamation Easter was elected School Board Chairperson for 2026 and continues being the Chair.

2. Election of Vice-Chairperson

Nominations were called for the position of Spring Lake Park Schools School Board Vice-Chairperson. Hennen was nominated by McClellan. No further nominations were made. By acclamation Hennen was elected School Board Vice-Chairperson for 2026.

3. Election of Clerk

Nominations were called for the position of Spring Lake Park Schools School Board Clerk. Skelly was nominated by Forsberg. No other nominations were made. By acclamation Skelly was elected School Board Clerk for 2026.

4. Election of Treasurer

Nominations were called for the position of Spring Lake Park Schools School Board Treasurer. Villella was nominated by McClellan. No further nominations were made. By acclamation Villella was elected School Board Treasurer for 2026.

5. Board Parliamentarian

Motion by Forsberg seconded by Hennen, to designate Kelly McClellan as the Board's Parliamentarian who shall rule on all parliamentary procedures and questions. Motion carried unanimously with all members present voting yes. (6-0)
