

Kindergarten Registration

Registration for the 2026-2027 school year will begin on **FEBRUARY 9, 2026**

Early registration is encouraged. Late registration potentially may be accommodated at a neighboring overflow school based on enrollments.

Registration is online at **dcsd.net/kinder**. After your child is registered online, parents must bring the following forms to the school site to complete registration:

1. Original birth certificate,
2. Complete and up-to-date immunization records as required by Nevada Law, and
3. Provide two primary proofs of residency, such as a utility bill, showing your current physical address.

You may enroll your child, however, your child may not start school until all immunizations are completed by the start of the 2026-2027 school year.

STATE OF NEVADA IMMUNIZATION REQUIREMENTS

Kindergartners and new students to the State of Nevada:

- ★ **DTP/DT/DTAP:** 4 doses are required. A 5th dose must be given if the 4th dose was administered before the 4th birthday.
- ★ **IPV/Polio:** 3 doses are required. A 4th dose must be given if the 3rd dose was administered before the 4th birthday.
- ★ **MMR/Measles Mumps Rubella:** 2 doses are required. Ideally, the 1st dose is after the 1st birthday and the 2nd dose is after the 4th birthday.
- ★ **Hepatitis A:** 2 doses are required and must follow the ACIP schedule.
- ★ **Hepatitis B:** 3 doses are required and must follow the ACIP schedule.
- ★ **Varicella (Chicken Pox):** 2 doses are required. Ideally, the 1st dose is after the 1st birthday and the 2nd dose is after the 4th birthday. If a child had a Varicella (chickenpox) diagnosis confirmed by a health care provider OR they have laboratory evidence of prior chickenpox disease, then it is not necessary to vaccinate regardless of age at time of infection.
- ★ **TDAP (Tetanus Diphtheria Pertussis):** 1 dose is required for all students entering the 7th grade and all new students in grades 8-12.
- ★ **MCV4 (Meningococcal Meningitis):** 1 dose is required for all students entering the 7th grade and all new students in grades 8-12. A 2 dose is required for all students who receive dose 1 before their 16th birthday. A 2 dose of MCV4 is required for all students entering the 12th grade.
