St. Anne Catholic School is moving to a Continuous Enrollment model for students entering Grades 1-8 for 2026-2027. Continuous Enrollment will automatically secure your student's enrollment for the upcoming school year and beyond. Please see below for more information.

## Frequently Asked Questions



### WHAT IS CONTINUOUS ENROLLMENT?

Continuous Enrollment is a contract that enrolls a student for the upcoming year and all subsequent years or until:

- The student graduates ~or~
- The family decides to opt out via written notice, which must be received by the School no later than **February 20, 2026**.

### WHY DID ST. ANNE SCHOOL MOVE TO CONTINUOUS ENROLLMENT?

We are constantly reevaluating our processes to ensure we serve our community the best way we can. As we find ourselves in a world where auto-renew and auto-draft have become commonplace practices, we believe this is the right time to transition to a similar enrollment method, eliminating the need for parents to complete a new enrollment contract for each student each year.

### HOW DOES CONTINUOUS ENROLLMENT WORK?

Starting in the 2026-2027 re-enrollment period, current students will no longer receive a contract to submit. If changes are needed, parents should contact us by the deadlines we provide and request that changes be made. There will be plenty of reminders and notifications as deadlines approach.

If you are like the majority of St. Anne Catholic School families who re-enroll each year and make no change to their tuition payment plan, you will not have to do anything moving forward!

### CAN I CHOOSE TO OPT OUT OF CONTINUOUS ENROLLMENT?

No, at this time, St. Anne School has decided to move forward with Continuous Enrollment to ease the re-enrollment process. We know that this process will be a benefit to our families.

### **WHERE CAN I FIND A COPY OF MY SIGNED CONTRACT GOING FORWARD?**

The signed contract copy is always saved in your parent portal profile by clicking on “Files & Forms” and checking the box “show completed form” under each child’s name. Please contact the Admissions Office at [admissions@st-anne.org](mailto:admissions@st-anne.org) with any additional questions or if you are unable to locate the contract.

### **WILL I NEED TO ADD MY BANK ACCOUNT INFORMATION EACH YEAR?**

No, banking information is saved year over year by Blackbaud Tuition Management (BBTM). Families will need to review and update their information each year or when changes occur.

### **WHAT IF I NEED TO CHANGE MY PAYMENT PLAN SELECTION?**

### **WHAT IF I AM APPLYING FOR TUITION ASSISTANCE AND NOT SURE IF WE CAN AFFORD ST. ANNE SCHOOL’S TUITION FOR THE COMING YEAR?**

The Tuition Assistance Committee begins accepting applications for returning students in February and new students in March. Families have until **June 30** to withdraw without owing any tuition. Registration fees are non-refundable, and this is our way of anticipating enrollment for the following academic year. Think of it as a placeholder for your child.

### **WHAT HAPPENS IF I WITHDRAW MY CHILD AFTER THE OPT-OUT DEADLINE?**
