### Goal 1

Percent of K-2 students scoring at or above benchmark in early literacy as measured by DIBELS will increase from 67% in June 2023 to 91% by June 2029.

#### *Interim Measure*

**Kindergarten:** Increase the percentage of K students scoring at or above benchmark in early literacy as measured by DIBELS from 73% (June 2023) to 97% by June 2029.

\*Hickory Grove currently at 89.4%

**1st Grade:** Increase the percentage of 1st grade students scoring at or above benchmark in early literacy as measured by DIBELS from 68% (June 2023) to 92% by June 2029.

\*Hickory Grove currently at 79%

**2nd Grade:** Increase the percentage of 2nd grade students scoring at or above benchmark in early literacy as measured by DIBELS from 62% (June 2023) to 86% by June 2029.

\*Hickory Grove currently at 60%

### Goal 2

Percent of students scoring CCR on Reading EOG in grades 3-8 will increase from 31% in September 2023 to 50% by June 2029.

#### *Interim Measure*

Grades 3rd - 5th : Increase the percentage of students scoring CCR on Reading final MVPA benchmark assessment in grades 3-5 from 33% (June 2023) to 52% by June 2029.

\*Hickory Grove currently at 16.7%

3rd - 12%

4th - 21%

5th - 17.4%
