REGISTRATION

- ◆ HCS follows a Continuous Enrollment model; all enrolled HCS families will be automatically enrolled each school year until the family opts out.
- ◆ Enrollment for new and returning students (who are in good standing) is on a first-come basis. If there is a waiting list for new students, being first on the waiting list is not a guarantee of next placement.

New Students

- ◆ New Student Registration Fee includes application, office records, supplemental student accident insurance, consumable supplies, and registration (due at the time of application). All fees are non-refundable.
- ◆ New Student Registration Fees are non-refundable unless the student is not accepted by Heights Christian Schools for enrollment. However, if a new student is accepted but later withdraws, the Registration Fee remains non-refundable.

Returning Students

- ◆ Re-Registration Fee includes consumable supplies, office records, supplemental student accident insurance, and consumable supplies.
- ◆ Re-Registration Fee is non-refundable for all returning students.

TUITION ACCOUNT, FEES AND PAYMENTS

- ◆ Tuition fees are effective August 24, 2026.
- ◆ Heights Christian Schools partner with Finalsity to provide secure and convenient payment through Auto Pay.
- ◆ **All tuition payments and incidental fees will be automatically drafted from the preferred payment method on the 1st of the month.**
- ◆ Multi-child discount applies to families with two or more children enrolled FULL-TIME at any of our schools.
- ◆ There are no other discounts other than those listed on the reverse side.
- ◆ The monthly tuition fee is the same regardless of how many days or weeks are in a month.
- ◆ The monthly tuition fee is the same regardless of sick days, vacation days, holidays, or mandated temporary closures or periods of quarantine or isolation.
- ◆ Accounts with any outstanding balance will be assessed a late fee of \$25 after the 5th of the month.
- ◆ When making a payment, the payment will first be applied to any outstanding balance on the account, and the remainder will then be applied to the current balance.
- ◆ Accounts that are not paid in full by the end of each month may result in the student being disenrolled.
- ◆ A service charge of \$30 will be assessed for each returned payment.
- ◆ A fine of \$1 per minute per child for late pick-up after 6:00PM will be assessed.
- ◆ A fine of \$5 will be assessed each time a parent does not digitally sign in and/or out OR use their full name when signing a paper sheet. Parents must sign their child in and out, per state regulations.
- ◆ A charge of \$1 will be assessed for each occurrence of the preschool having to provide a blanket and sheet for the child. State regulations require that each child have their own blanket and sheet to lie on for rest time. Parents are to provide a freshly washed blanket and sheet each Monday.
- ◆ Mid-month enrollment will be pro-rated for new families only.
- ◆ **A two-week written notice to the school office is required upon withdrawing your student.** Mid-month withdrawals will be subject to a tuition pro-rate **only** if the required two-week written notice is given to the school office. Families withdrawing their students the last day of the month **who do not give** the required two-week notice to the school office will have their account charged two week's pro-rated tuition.

PROGRAMS AND ATTENDANCE

- ◆ It is the parent's responsibility to notify the preschool office of any needed program changes.
- ◆ Parents can use our emergency drop-in if they need their child to attend on a day that is not part of their regular program. Daily rate fee is due at the time of student drop-off. Drop-ins accepted if space permits.
- ◆ Credit is not given for missed days regardless of the reason; there is no swapping of days.

HOLIDAYS AND TEACHERS' IN-SERVICE DAYS

- ◆ Our preschool is open year-round. We are closed on the following days: Presidents' Day, Good Friday, Memorial Day, Week of Independence Day (Monday-Friday), Labor Day, Thanksgiving (Thursday-Friday), Christmas Break (typically December 24 at noon through January 1), and Teachers' In-Service Days (see preschool calendar).
