* *Fixed Fees and 10% of the annual tuition are non-refundable and are due in full regardless of enrollment date, financial assistance, or scholarships received, or withdrawal date, if applicable.* Note there is a credit card convenience fee of 3%.

Payment Plans

Every family is required to select a tuition payment plan at the time of enrollment/ re-enrollment. There are three payment plan options. The payment plan includes tuition and the Campus Improvement and Security Fee in equal installments consistent with the payment plan selected. All payment plans include the non-refundable tuition installment (which is 10% of the annual tuition).

Beginning on June 1st, 12 monthly installments based on the Total Annual Cost will be due which include Annual Tuition and Fixed fees.	One full payment is due on June 1st. Multiple Child Discount

Tuition is assessed at the full rate for the oldest student attending Florida Christian School from the same family (household). A multiple child discount is granted to offset tuition for each additional sibling enrolled living in the same household at the following rates:

10% discount – 2nd student

20% discount – 3rd student

30% discount – 4th student

Regardless of the payment plan selected, the non-refundable fees are as follows:

1. Enrollment Fee: \$500
2. Campus Improvement & Security Fee: \$1,000
The Campus Improvement and Security Fee of \$1,000 will be billed to each family (household) following enrollment. The Campus Improvement and Security Fee may be paid over installments consistent with the payment plan selected. Regardless of the payment plan selected, the non-refundable Campus Improvement and Security Fee is due in full to FCS.

Book/Class Fee

The cost of textbooks and workbooks for all students is now included in the monthly tuition payments. Textbooks will be purchased by the school and provided to students at the beginning of the school year. Additionally, Classroom Celebration fees are included in Elementary and Preschool tuition to cover your student/s for all class parties during the year.

Withdrawal – Dismissal

When seeking a withdrawal from school, please contact the Admissions Department. A Withdrawal Form must be signed by the financially responsible parent or legal guardian. After careful consideration, a student may be dismissed when he or she is found out of harmony with the [regulations and policies](#) of the school.

If dismissed or withdrawn, students must turn in all school-issued equipment, team uniforms, library books, etc., on his/her last day of attending school. All accounts must be cleared (no past-due balance) for records to be released.

Following a student's withdrawal or dismissal, school records and report cards will not be given to families whose financial account is past due. Students who attend a portion of a month will be liable for the entire month of tuition. Application Fees, Enrollment Fees, and Campus Improvement and Security Fee are due in full, regardless of the payment plan selected or withdrawal date. Additionally, the withdrawing student will be charged a \$250 book fee for the textbooks purchased for them by the school. Families who withdraw their student or who are dismissed will not receive a refund. Refunds permitted will be for those families who have paid in advance more than one month of tuition for periods after the withdrawal/dismissal date.

After School Care (Pre-school through 8th grade students)

Our After School Care program is open until 6:00 PM every day that school is in session. This service is provided to you at a daily or monthly rate in addition to your tuition charges. The following chart details the daily and monthly rates:

Daily: \$ 20

Monthly: \$ 250

Surcharge: \$25/1st 10 minutes, or any part thereof, and \$10/10-minute interval, thereafter, will be charged to any student who is picked up after 6:00 PM.

Other Fees and Services

Student support services such as Educational Therapy, Academic Enhancement, Search & Teach, Intensive Reading, and Intensive Math have separate rates as to what is mentioned above. Prices can range from \$2,600 to \$8,000.

International Students

New Student International Enrollment Fee (Non-Refundable) The enrollment fee is due through FACTS Online Enrollment upon acceptance of a new student. All Grades: \$3,000 (\$500 due at completion of enrollment packet; remaining \$2,500 billed to the student account.)

Tuition & Fees Payment Policy

To ensure clarity and consistency in tuition billing, Florida Christian School partners with FACTS Tuition Management for all payment processing. Please review the following policies regarding due dates, mid-month enrollment, and returned payments so families can plan confidently and avoid unexpected fees.

Full Monthly Charge

Tuition is not prorated. Students who begin mid-month are responsible for the full month's tuition.

Initial Payment Requirement

Students who start mid-month must pay their first month's tuition within 5 days of enrollment, regardless of pending financial aid. This payment will be automatically withdrawn through the payment method on file with FACTS.

Monthly Due Date

All tuition payments are due on the 5th of each month, regardless of the student's start date.

Returned Payments

If a payment is returned or does not process on the 5th, it will be considered 30 days past due on the 5th of the following month. A \$50 late fee will be applied.

FACTS Tuition Management

We partner with FACTS Tuition Management Service to process all payments automatically. Please review their payment policies on their website, or request a copy from our Business Office.
