Principal's Message

Buckeye Elementary School, a 2010 California Distinguished School and 2017 STAR Honor Roll School, 2021, 2023, and 2025 PBIS Coalition Gold Medal winner, is home of the Bobcats. Built in a wide-open oak woodland, our campus is beautiful and inviting. For many years Buckeye School was the only school in a one-school district. Located in Shingle Springs, a rural part of the gold country, our school is rich in history and is the heart of our community. Although we are the oldest school in our community, we have consistently maintained a commitment to innovative instruction and excellence in education.

Our school is equipped with the latest in educational technology that inspires our staff and engages our students. We are

currently one to one with devices in Kindergarten through 5th grade, internet connected student computers in each classroom, teacher laptop computers, document cameras, and TV boards in every classroom. Each classroom has a Chromebook cart which allows each student to have their own laptop to work on school projects. We have had extensive professional development in the use of technology to enhance student learning. All of this adds to an already exciting learning and teaching environment.

Our school demographics reflect the rural community that is truly Buckeye. We provide a wide variety of programs that support the different needs of our students. Buckeye Elementary receives additional funds through the Title 1 program which we put to work for all students to meet or exceed standards. Bobcat Reading Boost or BRB is our signature reading intervention program which provides students with differentiated instruction in the area of reading. We are also able to hire five reading teachers that work with each grade level for part the of the school day to give students additional small group reading opportunities. In addition, we also have two math intervention teachers to work in our 2nd-5th grade classes four days a week to support the current learning and give more small group support. Furthermore, we have a dedicated ELD teacher to support our English learner students four days a week. These programs were added to address our student's needs and readiness for school. Our site houses the district's food service facility and our breakfast program is popular with many Buckeye students.

Additional enrichment is now becoming a cornerstone of Buckeye. We have an elementary band program that we provide before school for interested 4th and 5th graders. We have a Robotics Club after school for some of our 4th and 5th graders which provides opportunities to work on high level collaborative projects. Our Cross Country team runs in the Fall and competes at a high level against schools across our county. We also offer a 4th/5th grade girls basketball team and 4th/5th grade boys basketball team that practices in the winter and competes against other schools in our area. In addition, our school participates in Unified Sports which gives our students with special needs an opportunity to participate in organized, competitive sports such as soccer and basketball alongside their typical peers who act as mentors during practice and games. Finally, we have many lunchtime clubs that have been created by our students including student leadership and book clubs.

School Profile
Buckeye Elementary School is one of six elementary schools and three middle schools in the Buckeye Union School District. The district was established in 1858 and currently serves the communities of Shingle Springs, Cameron Park and El Dorado Hills in El Dorado County.

During the 2024-25 school year, 323 TK-5th grade students were enrolled at the school, with classes arranged on a traditional schedule.

School Facility Conditions and Planned Improvements

The Buckeye Union School District is proud of the facilities that are provided for students and families. Each year parent surveys indicate that they are pleased with the condition of the schools.

Buckeye Elementary was originally constructed in 1957 and is comprised of 25 classrooms, one multipurpose room, one administration building, one library, one staff room, one computer lab, and two playgrounds. Measure K allowed for remodeling in 2009 of the library and computer lab; staff and workroom; district-wide food services kitchen; refinishing of sidewalks and blacktops; and technology addition of Promethean boards and classroom computers. Renovations basketball courts, and blacktop were completed in the Summer of 2017. In 2022, the Promethean boards were replaced with 86" Newline interactive displays. In 2024, a Verkada perimeter security camera system was installed. During the summer of 2025 the kindergarten play structures were replaced, and removal and replacement of the concrete kindergarten play area is scheduled for the Summer of 2026.

Cleaning Process

The principal works daily with the custodial staff to ensure that the school is cleaned and maintained to provide for a clean and safe learning environment.

Maintenance and Repair

District maintenance staff ensures that the maintenance and repairs necessary to keep the school in good repair are completed in a timely manner.

Professional Development

As part of the growth process, opportunities for training and staff development are provided at both the District and individual school sites to administrators, teachers, and classified staff. In a typical year, the District offers three staff development days annually, where staff members are offered growth opportunities in curriculum, teaching strategies, and methodologies.

With the new iReady math adoption three years ago, our staff has had professional development with the publishers of iReady to look at best practices around implementation and utilization of student data to ensure our students are getting the most out of the program. These trainings happened periodically throughout the 24-25 school year. There remained a focus on strategies to differentiate instruction to meet the needs of a variety of learners in the classroom, trauma informed practices to support the social and emotional needs of our students, teacher clarity, teacher efficacy, and data review related to formative and summative assessments to inform future instruction and student supports. Our staff has been learning about the Zones of Regulation in order to support our students at Buckeye.

Staff is offered support through the Peer Assistance Review (PAR) program and new educators can find mentors through the Teacher Induction Program (TIP).
