12. **Motion to approve** the out-of-district placement of student ID #7804500856 to Newton Board of Education (Sussex County) effective February 2, 2026 through the date the student is placed at an appropriate out of district placement, at a tuition cost of \$3,475.50 per month with a final bill tied to the final day of enrollment, plus related services.

13. **WHEREAS**, the Board of Education ("Board") is required to provide a Free Appropriate Public Education (FAPE) to all students with disabilities pursuant to N.J.A.C. 6A:14 and IDEA; and **WHEREAS**, the Student ID #5877860015 requires a special education placement, as outlined in their Individualized Education Program (IEP); and **WHEREAS**, the Board has determined that Mansfield Township School District is an appropriate placement; and **WHEREAS**, the tuition rate for the [2025-2026] school year shall be in accordance with the maximum tentative per diem rates established by the NJ Department of Education, estimated at **\$24,713 (2,471.30 per month)** (not including applicable extraordinary services/transportation); **NOW, THEREFORE, BE IT RESOLVED**, that the Board approves the tuition contract for Student ID 5877860015 from Alpha Public School District effective February 23, 2026 through June 30, 2026.
