Hollis Brookline Cooperative School District

To see if the Cooperative School District will vote to require the Hollis Brookline Cooperative School Board to prominently display current and previous year state assessment scores and state rankings on the cooperative school district website header, visible on every page, with said information to be updated within thirty (30) days of the official release of scores by the New Hampshire Department of Education.

Explanation of Article

This article would require the Hollis Brookline Cooperative School District to maintain transparency regarding student academic performance by posting state assessment results in a consistently visible location on the district website. Specifically, the district would be required to:

1. Display both current year and previous year state assessment scores
2. Include the district's state ranking among New Hampshire school districts
3. Place this information in the website header so it appears on every page of the website
4. Update the information within 30 days of official score release by the NH Department of Education

Rationale: This measure would provide parents, taxpayers, and community members with immediate access to key performance metrics, promoting accountability and informed decision-making regarding cooperative school district performance.

Fiscal Impact: Minimal - requires only website maintenance within existing technology staff duties.


