

OPEN-ENROLLMENT

The Lordstown Board of Education will permit the enrollment of students who are residents of other school districts in Ohio. Guidelines for the transfer of students based upon criteria established by the board of education and consistent with Ohio Revised Code 3319.98 are listed below.

1. All current open enrollment students (as of the fourth quarter of school year 2025- 2026) can re-apply for open enrollment for the 2026-2027 school year.
2. The application for inter-district transfer into Lordstown Schools must be submitted to the Superintendent's office by **May 1st**. The Lordstown Board of Education will need to revise and/or extend the application window by resolution if they choose to do so. Applications will be acted on no later than **July 10th** and parents will be notified in writing. A notice of approval shall be sent by the Lordstown Local School District to the student's parent(s) and to the Superintendent of the student's "home" district.
3. One application must be submitted for each student who requests an inter-district transfer. Applicants shall be considered annually and students participating in this program must re-apply the following year. Students not enrolled in the Lordstown Local School District will be accepted on a priority basis as follows:
 - Native students to the Lordstown Local School District.
 - Native students of families who choose to home school and attend on a part-time basis.
 - Students whose parents are employed by Lordstown Local Schools.
 - Students of contracted staff members.
 - Students of families who are buying or building a new home in the school district, more than ninety (90) days after the beginning of the school year.
 - Students whose legal residence is located outside the Lordstown Local School District boundaries based on the following order:
 - Students who have participated in the District's open enrollment program in previous years.
 - Siblings of students who have been a part of the district's program in previous years.
 - New Applicants.

4. No inter-district transfer will be permitted if the enrollment of the grade level being requested exceeds the number of students that would deem that grade level is full. (Allowance must be made for new students moving into the district). These limits 2 may be changed annually upon review by the Board of Education. At this time the average class size limits, for open enrollment purposes, are set as follows:

Grade	Enrollment Limit
Kindergarten	20
1st-4th Grade	23
Grades 5-6	25
Special Education	16

Limits for grades 7-12 shall be based on a per pupil average per section of 28. Elementary maximums will be based on an aggregate of 20/23/25 students per class and 16 students per special education class. Special education classes will enroll students in accordance with caseload regulations.

- 5. No student, once accepted by Lordstown Schools, will be displaced should enrollment exceed the limits stated above.
- 6. The Board of Education is not required to institute any education program, including special education programs, to serve open enrollment students. There will be no limitation on admitting a student with a disability unless services required in an IEP are not available in the district.
- 7. Parents are required to provide transportation to the Lordstown Local Schools or to an existing bus stop within the district if seating is available. **Students are to be picked up and dropped off at times instructed by the school building principal.**
- 8. All approved applications for open enrollment are good for one (1) school year only. Applications must be renewed yearly. Lordstown Schools has the right to revoke open enrollment status at any time for excessive tardiness, excessive absenteeism disciplinary violations, and/or poor academic performance.

9. Applications shall be considered on a first-come, first-served basis with an assurance that resident Lordstown students will not be displaced from academic programs by applicants.
10. Open enrollment students shall be afforded the same opportunities for participation in athletics and extra-curricular activities as native Lordstown students provided that all Ohio High School Athletic Association rules are met. **It is the responsibility of the parent/guardian to become familiar with current Ohio High School Athletic Association guidelines as to athletic eligibility prior to applying for or accepting admission.**
11. The Lordstown Local School District reserves the right to deny enrollment to students with more than five (5) unexcused tardies and/or absences in the term for which admission is sought or the immediately preceding term. Official and unofficial court referrals may also be filed.
12. Students must be enrolled in their district of residence prior to acceptance in the open enrollment program.
13. A student must meet all graduation requirements established by the Lordstown Board of Education and the Ohio Department of Education to graduate from Lordstown High School. The Board of Education shall accept all credits toward graduation earned in adjacent or other district schools.
14. Applications turned in to the Superintendent's office that are **NOT** accompanied by all of the necessary documents required will not be considered for Open Enrollment. **The District will not contact you for missing paperwork.**
