Chemical pest management practices

- ✓ If non-chemical methods are ineffective, the school district will consider pesticides only after careful monitoring indicates that they are needed according to pre-established action levels and will use pesticides that pose the least possible hazard and are effective in a manner that minimizes risks to people, property and the environment.

This school district expects the following pesticides (pesticide products and active ingredients) to be applied during the year. (This list includes pesticides that will be applied by school district staff or licensed pest control businesses).

The district uses EPA-registered disinfectants such as Bioesque Botanical Disinfectant Solution for routine cleaning. These products are exempt from notification under the Healthy Schools Act as they are classified as antimicrobial disinfectants—not pesticides used for pest control.

Training

Submittal of pesticide use reports

- ✓ Reports of all pesticides applied by school district staff during the calendar year, except pesticides exempt from HAS recordkeeping, are submitted to the Department of Pesticide Regulation at least annually, by January 30 of the following year, using the form provided at www.cdpr.ca.gov/schoolipm. (Education Code Section 16711)
