8:20 AM Informational Item: Principal’s Update (Scheifflee)

Mr. Scheifflee provided an update how our athletes are performing and initiatives the school is taking to ensure students and parents are well informed about our athletic program and opportunities for students new to sports. Mr. Scheifflee went on to share about our theatre program and the Spring production of Spamalot. He also highlighted that AHS has the 2nd highest finalist representation in the GHP program, just behind Innovation Academy. Our student, Jonnalagaddba, suggested allowing last year’s finalists an opportunity to assist this year’s finalists with preparations. Mr. Scheifflee acknowledged that it was a good idea and plans to reach out to Mrs. Copeland.

Mrs. Taylor pointed out that GA will require the submission of students SS# if they plan to participate in dural enrollment, the HOPE scholarship, GA Match program and GA Futures Account.

Mr. Scheifflee reassured that submission of SS# is not being linked to a student’s status. Students should feel safe coming to school. AHS does not track or release records. Any ICE concerns are handled through the district.
