

# FAMILIES LIVING IN TRANSITION: McKinney-Vento



We are dedicated to supporting students experiencing homelessness, as defined by the McKinney-Vento Homeless Assistance Act, in all public school districts and public school academies throughout Oakland County.

## ***Students may be eligible for support if:***

- Living in a shelter or transitional housing program.
- Living in cars, parks, public spaces, abandoned buildings, substandard housing, bus or train stations, or similar settings.
- Living in motels, hotels, trailer parks, or camping grounds due to the lack of alternative adequate accommodations.
- Sharing the housing of other persons due to loss of housing, economic hardship, or a similar reason.
- Living in inadequate living conditions (unsafe housing, lack of heat or running water).
- Unaccompanied youth experiencing any of the above situations.

Under the McKinney-Vento (MV) Homeless Assistance Act, the term “homeless children and youth” means individuals who lack a fixed, regular, and adequate nighttime residence.

## Eligible Students Have the Right to:

- Receive a free, appropriate public education.
- Enroll in school immediately, even if lacking documents normally required for enrollment.
- Enroll in school and attend classes while the school gathers needed documentation.
- Enroll in the local school; or continue attending the school of origin (the school they attended when permanently housed or in which they were last enrolled), according to each student's best interest.
  - If the school district believes that the school selected is not in the student's best interest, the district must provide the parent, guardian, or unaccompanied youth with a written explanation of its position and inform the parent, guardian, or youth of the right to appeal its decision.
- Receive transportation to and from the school of origin, if requested.
- Receive educational services comparable to those provided to other students, according to each student's needs.
