Locations</p> <p>Bid request for 2026 grounds maintenance of the lagoon areas for Lawrence County Schools.</p> <ul style="list-style-type: none">*Mowing & vegetation maintenance at Mt. Hope, Hatton, East Lawrence, and Speake.*At East Lawrence, this bid includes the area between the lagoon fence, the baseball field, and the football stadium.*At Hatton, this bid includes the area between the lagoon fence and the road on the North and East sides. It also includes the area around and inside the retention basin by the new practice field.*Bid is for mowing/bush hogging to a height of 6" or below.*Bid is for 4 cuts to be spread between April (after board approval) and November 15th and determined by growth.*Vegetation must be cut down to the water's edge. Hand trimming may be needed.	

*Most all areas have recently been mulched or mowed with a skid steer.

*Some areas are very steep and some tree stumps are still present. Some manual trimming will be needed.

*Water edges may be trimmed or sprayed with diquat herbicide products.

*Fence lines may be sprayed with a non-selective herbicide to minimize hand trimming.

*Invoices may be submitted after each cut has been completed for the entire bid area. The four invoices shall equal up the total bid amount at the end of the season.

*Bidders shall be fully insured.

*A pre-bid showing of the maintenance areas will be held on Tuesday, March 10th beginning with the Speake lagoon at 8:00 am.
