Bids opened and read shall remain irrevocable for a period of sixty (60) days.

Proposal must be accompanied by a Certified Check in the amount of ten percent (10%) of the total bid, made payable to the Morris Hills Regional District, OR a bid bond for a like sum, executed by a Surety Company authorized to do business in the State of New Jersey. A guarantee of surety must be included in or with the bid security.

A performance bond of one hundred percent (100%) MAY be requested by the School District participating in the bid, and, if requested, must be submitted within ten (10) days.
