

**Resolution # 451**  
**Columbia Falls School District Six High School District**  
**Intent to Impose an Increase/Decrease in Levies**

WHEREAS, as an essential part of its budgeting process, the High School District Board of Trustees is authorized by law to impose levies to support its budget.

BE IT RESOLVED, that the Board of Trustees of School District Number Six, Flathead County, Columbia Falls, Montana is estimating the following changes in revenues/mills to support the High School District budget for the 2026/27 school year using certified taxable valuations from the current school fiscal year as provided to the District:


\*Annual impacts above are based on current certified taxable valuations from the current school fiscal year.
