The legal voters of the Blue Mountain Union School District #21 (the “District”), comprising the legal voters, respectively, of the Towns of Groton, Ryegate, and Wells River, are hereby NOTIFIED AND WARNED to attend a Public Informational Hearing at the Blue Mountain Union School in Wells River, Vermont on Monday, March 23, 2026 at 6:00PM. Said meeting will be regarding the proposed budget to be voted on by Australian Ballot, on Wednesday, March 25, 2026.

The legal voters of the Blue Mountain Union School District #21 are further notified and warned to meet at the following locations:

Ryegate: Town Hall in Ryegate Corner
Groton: Groton Community Building in Groton
Wells River: Village Garage in Wells River


On Wednesday, March 25, 2026 between 10:00 in the morning and 7:00 in the evening, there will be a vote by Australian Ballot on the following question:


Article #1:

Shall the voters of the school district approve the school board to expend \$12,756,291.00 which is the amount the school board has determined to be necessary for the ensuing fiscal year? The Blue Mountain Union School District estimates that this proposed budget, if approved, will result in per pupil education spending of \$15,871.12 which is 19.06% higher than per pupil education spending for the current year.


The legal voters of the Blue Mountain Union School District #21 are further notified that voter qualification and registration relative to said Budget Vote shall be as provided in Section 706u of Title 16 and Chapters 43, 51 and 55 of Title 17, Vermont Statutes Annotated.




