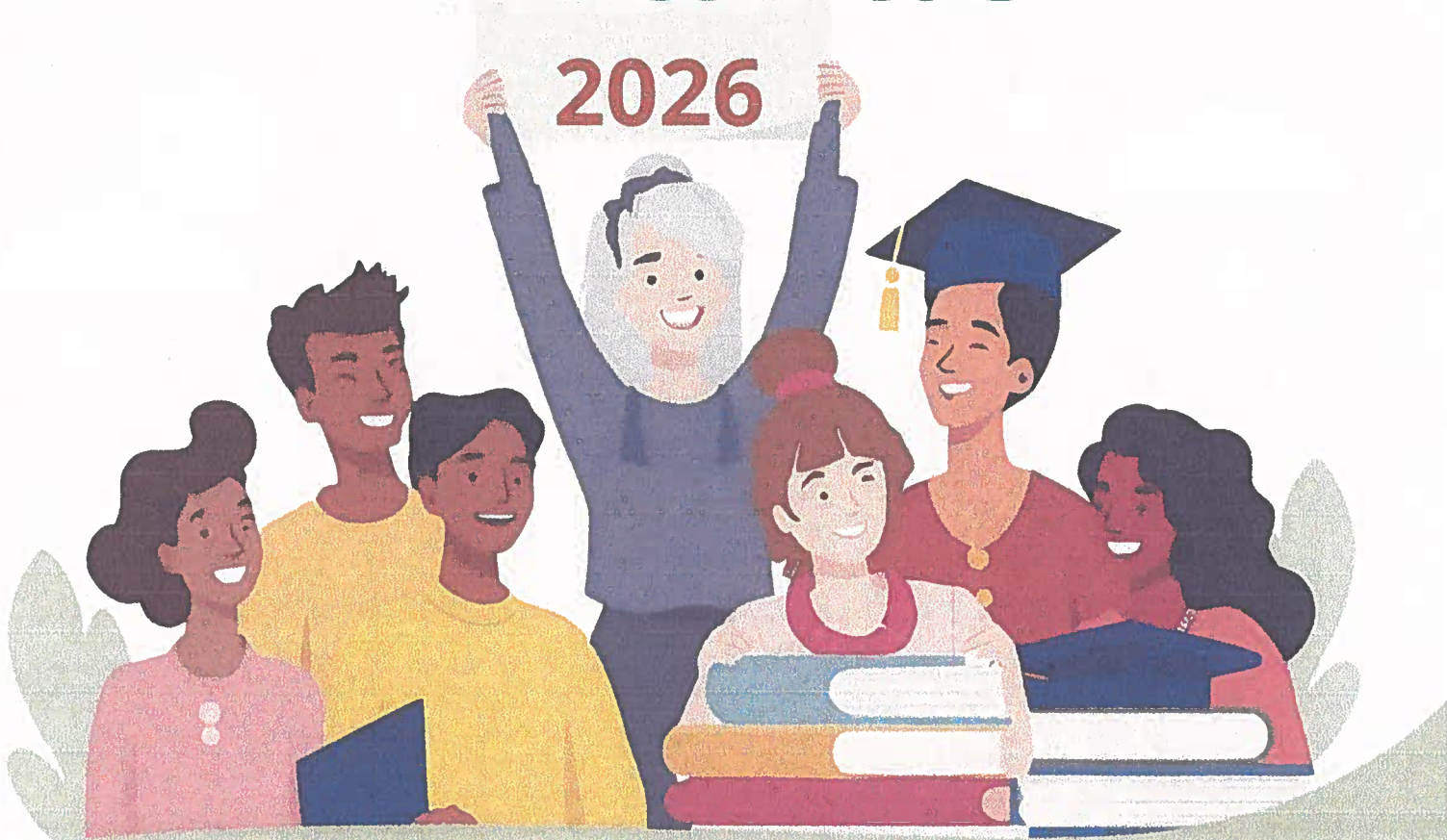

The NE PA Community FCU Foundation Educational Awards are presented to students for study at a post-secondary institution or program to support their tuition and related expenses. Examples of post-secondary schools or programs might be a: four year college, two year college, community college, online college/school, certification program, apprenticeship program, etc.

ELIGIBILITY REQUIREMENTS

All Applicants Must:

- 1) Be a resident of Monroe County or Pike County in Pennsylvania for at least one year
- 2) Complete this Official Application, postmarked or hand delivered to NEPA Community FCU Foundation c/o UECU, 337 Clay Avenue, Stroudsburg, PA 18360, no later than June 1st
- 3) Include a copy of **ONLY** the pages of your parents’ current Federal Income Tax Return Form that show **adjusted gross income and number of dependents.**
- 4) Include a copy of **ONLY** the page of your current Federal Income Tax Return Form that shows **adjusted gross income**
- 5) Include **ONLY** the FAFSA page that shows/indicates **whether or not** you are eligible for **any student PELL Grant and/or Federal Loan.**
- 6) Include all high school and post-secondary transcripts
- 7) Include two letters of recommendation
- 8) Include a one-page essay, signed and dated
- 9) The award can only be awarded to the same applicant twice

All personal identifying information regarding the applicant (such as name, address, etc.) will be redacted prior to review by the selection committee.
