## Pavilion Rules and Regulations – Chesley Park

### PERMIT REGULATIONS:

1. *Chesley Splash Pad Pavilion* rentals are available Sunday through Saturday, June through August, during the 8 weeks the bath house is open (typically the 3<sup>rd</sup> week in June through the 2<sup>nd</sup> week in August). The pavilion is available to rent in 4-hour blocks; 11:00am – 3:00pm and 4:00pm – 8:00pm.
2. *Chesley Playground Pavilion* rentals are available Sunday through Saturday, Memorial Day through Labor Day. The pavilion is available to rent in 4-hour blocks; 11:00am – 3:00pm and 4:00pm – 8:00pm.
3. Pavilion permits will be available starting January 15<sup>th</sup>. Pavilion Permit Application can be completed online or in office by the applicant, applicant must be 18 years of age or older. Permit fees for pavilion rental are due and payable in full at the time of reservation.
4. Pavilion Permit Applications will be taken on a first come, first served basis. Pavilion Permit Applications can be completed online through MyRec or be submitted in office.
5. Refunds: There are NO REFUNDS or CANCELATIONS AFTER APRIL 15th.
6. Inclement Weather: pavilion permits are rented on a rain or shine basis. **NO REFUNDS** will be issued for inclement weather.
7. Permit holder must keep the original picnic permit on-site at all times. No duplicate permits will be issued. New Britain Police can request to see your permit along with a valid ID at any time.

### FACILITY RULES:

8. Alcohol is prohibited in the park and in the pavilion.
9. Smoking is prohibited in the park and pavilion.
10. Grilling is prohibited. **Only prepared food allowed.**
11. Pavilion must be cleaned after use. Trash must be removed and placed in the proper trash receptacle. Failure to properly clean will jeopardize future rental permits.
12. Parking is available in the parking lot behind the splash pad (adjacent to John Downey Drive) or in the parking lot located next to the NBPD Substation on Wildwood Street. Parking is prohibited on Wildwood Street.
13. Excessive noise and amplified music is not permitted.
14. Decorations may not be attached in any way that damages or alters park property and must be completely removed and cleaned by the end of rental period. There is no staking decorations or equipment into the ground. Tables must not be moved and littering is prohibited.
15. Lavatory facilities: portable toilets are available throughout the park. The bath house restrooms are open from 10am – 8pm during June through August.
16. Pavilion rentals are based on a 4-hour time block. Pavilion must be properly cleaned at the end of the rental. Failure to properly clean may jeopardize future rental permits.
17. Pavilion capacity: Splash Pad Pavilion has 8 tables/60 people. Playground Pavilion has 5 tables/50 people.

### MISC. INFORMATION:

18. Chesley Park offers a family-destination splash pad. There is no entry fee for the splash pad. Hours of operations are Memorial Day to Labor Day, Monday through Friday, from 10am – 8pm. Bathing suits are recommended.
19. Chesley Park Splash Pad cannot be reserved exclusively for those renting the picnic pavilion.
20. Inflatables/attractions (i.e. moonwalks, bounce houses, etc.) need to be rented **exclusively through the New Britain Recreation and Community Services Department**. Location of inflatable amusements to be determined by recreation staff based on electricity availability.
21. Chesley Park pavilions are outdoor facilities. Keep in mind that these picnic areas are located in parks with trees, grass, dirt, and animals. There may be times when the natural debris affects the conditions of the picnic site.
