

Pequea Valley High School Learner Contract

Junior-Senior Prom

April 24, 2026

The Prom will be held this year at the Eden Resort, Eden Rd (Oregon Pike exit off Route 30), Lancaster from 5:00-10:00 PM. All members of the Junior and Senior classes and their guest (no more than one) are invited to attend. Guest (1) must be in at least the ninth grade and under the age of 21 (20 years old or younger).

The Prom is one of the many school activities held for the enjoyment of the learners and all participants. Learners and guests are expected to act like responsible individuals. All school policies and procedures continue to be in effect, despite the fact that the prom is not held on school property.

All learners and guests must be aware of the following:

1. Possession of or being under the influence of alcohol, drugs, or tobacco products is strictly prohibited and will result in disciplinary consequences. Learner and guest who appear to be under the influence may also be required to leave the Prom.
2. **Brick and mortar learners, as well as CTC learners, must be in school the day of the prom from 7:55-11:13 AM on the day of the Prom UNLESS a High School Administrator has granted prior approval for the absence. Additionally, if a brick and mortar student does not have a 4th period class, they may leave at the conclusion of their last morning class. If you are ill and miss school the day of the Prom, you may not attend the Prom.**
3. Learners are permitted to bring guests with the understanding that each P.V. Learner is responsible for the behavior of his/her guest. Should the guest violate any rules, both the guest and the learner will be asked to leave. PV learners are responsible for communicating the expectations of appropriate behavior with their guests.
4. Learners and guests are required to register upon arrival. Everyone will remain at the Prom until at least 8:45 PM. No learner or guest may exit the prom prior to that time and return to the Prom. Parents will be called if anyone leaves early for any reason.
5. **Learners or guests who are asked to leave the Prom and those who cannot attend because of absence or disciplinary action will not have their money refunded.**
6. The school does not sponsor any post-prom activity. Parents are responsible after learners leave the Prom.
7. Persons who have been banned from school events due to disciplinary or school related issues may not attend the Prom. If you feel your Prom date/Guest may be subject to this ruling, please make an appointment with a High School Administrator to discuss the matter **before** purchasing a Prom Ticket.
