Dear Parent/Guardian,

The Board believes that all persons in grades kindergarten through eighth grade who reside in the Rockaway Borough School District may attend District schools. All persons eligible for admission to the District's schools and who are domiciled within Rockaway Borough without a lease or deed must provide proof of domicile, in the form of a sworn statement.

If you are currently living in a home or apartment owned or managed by a Rockaway Borough owner/manager **without a lease and without paying rent**, and you are requesting admission for your child to Rockaway Borough Schools, the attached affidavits must be completed and notarized before your child can be admitted.

The **Parent/Guardian Affidavit** must be completed by the parent(s) or guardian(s) requesting admission for the student. The **Owner/Manager Affidavit** must be completed by the Rockaway Borough owner or manager of the home or apartment where you are residing.
