ARTICLE 1: To elect the following School District Officers for the ensuing year: Moderator, Clerk and Treasurer.


ARTICLE 2: To hear and act upon the reports of the Officers and School Directors.

The Unified Union School District estimates that this proposed budget, if approved, will result in per pupil education spending of \$12,475.87, which is 12.96% higher than per pupil education spending for the current year.
