Board President Emily Davies called the meeting to order at 7:00 pm. Board members present were Emily Davies, Levi Mallory, Cassie Kleeman, Darin Kincaid, and Jake Haley. Sharon Wright was absent. Jamie Clevenger arrived at 7:01 pm. Also in attendance were Superintendent Mr. Daniel Street, Elementary Principal Tyna Morrison, Secondary Principal Chad Boyles, Athletic Director Angie Stone, and Bookkeeper Brooke Westcott. Parents Poet and Carie Sanders were also in attendance, along with educators Becky O'Dell, Erika Swindler, and Traci Heussner. Presenters in attendance were Kasey Bailey of the Root Ed Program, and Dr. Rinehart of LJ Hart.

Cassie Kleeman made a motion to approve the agenda. Levi Mallory seconded the motion and all members present voted yes.

Levi Mallory made a motion to approve the consent agenda, including previous Board Meeting minutes, financial statements and payment of bills, and the current substitute list. Cassie Kleeman seconded the motion and all members present voted yes.

Poet Sanders presented to the Board regarding the current Attendance Policy.

Kasey Bailey presented to the Board regarding the Root Ed Program.

Dr. Rinehart presented to the Board regarding finance options.

The Board reviewed Administrative reports, followed by the Superintendent's report.
