OXBOW UNIFIED UNION SCHOOL DISTRICT
ANNUAL MEETING
April 28, 2026

The legal voters of the Oxbow Unified Union School District (the “District”), comprising the legal voters, respectively, of the Towns of Bradford and Newbury, are hereby NOTIFIED AND WARNED to meet at the Oxbow High School in Bradford, VT on the 28th day of April, 2026 at 6:30 p.m. to conduct the following business:

- ARTICLE 1: To elect a Moderator for a term of one (1) year.
- ARTICLE 2: To elect a Clerk for a term of one (1) year.
- ARTICLE 3: To elect a Treasurer for a term of one (1) year.
- ARTICLE 4: To hear and act upon the reports of the officers of said District for the past year.
- ARTICLE 5: To elect two school directors of said District (one (1) to represent the Town of Bradford for a three-year term to expire 2029 and one (1) to represent the Town of Newbury for a three-year term to expire 2029).
- ARTICLE 6: Shall the voters of the school district approve the school board to expend twenty-three million, three hundred thirty-nine thousand, three hundred thirty-three dollars (\$23,339,333.00), which is the amount the school board has determined to be necessary for the ensuing fiscal year? The Oxbow Unified Union School District estimates that this proposed budget, if approved, will result in per pupil education spending of \$15,410.35 which is 16.46% higher than per pupil education spending for the current year.
- ARTICLE 7: Shall the voters of Oxbow Unified Union School District authorize the use of forty-one thousand dollars (\$41,000) of the FY 25 surplus be applied to the Capital Improvement Fund?
- ARTICLE 8: Shall the voters authorize the School Board to borrow money in anticipation of tax receipts for the 2026-2027 school year?
- ARTICLE 9: To transact any other business that may legally come before this meeting.

The legal voters of the Oxbow Unified Union School District are further notified that voter qualification and registration relative to said Annual Meeting shall be as provided in Section 706u of Title 16 and Chapters 43, 51 and 55 of Title 17, Vermont Statutes Annotated.

Prior to the annual meeting, the public information hearing will be held on April 28, 2026 from 5:00 pm - 6:00 pm.
