Bid#FY23-01 – General Construction, Repairs, Specialty Trade & Carpentry Services

The competitively bid pricing reflected in the Price List to follow represents the baseline with which to establish the total fixed cost of respective projects based upon an agreed scope of work between the Member and the Vendor/Contractor. After consultation with legal counsel, we recommend that the Vendor/Contractor project proposal for public works projects provide a total fixed cost and should not specify actual hours worked nor may it provide a variable cost of project materials or equipment.

Additionally, members shall ensure compliance by:

- Making sure the New Jersey Prevailing Wage Act (NJPWA) is being followed for all public works contracts
- Securing Certified Payroll Records for each public works project
- Visit the NJ Prevailing Wage Debarment List regularly to make sure the contractor(s) is not listed

The Camden County ESC reserves the right to change/modify its approach as more guidance and/or regulations are presented. I am hopeful this notice provides Members the clarity needed to move forward in the way they feel most appropriate.





Upon approval by the Director of NJ Division of Local Government Services, future registered members shall be able to use this contract. Registered members who submit estimates shall not issue orders and contractors shall not make deliveries, that deviate from the specifications or price as set forth in the master contract. .
