**Puerto Rico Trip 0:05:48**

**Motion: Mr. Mascola motioned to approve second reading and adoption of policy KFB – Assaults on School Property. Mrs. Withee seconded. With no further discussion the motion passed by unanimous vote of 8-0-0.**

**New Hampshire School Board Association Resolutions 0:57:18**

Mr. Barczak presented two resolutions to be submitted to the New Hampshire school Board Association (NHSBA).

**Motion: Mr. Mascola motioned to approve resolution #1 urging the United States Congress to abolish the US Department of Education. Mr. Barczak seconded. With no further discussion the motion failed by a vote of 2-6-0 (Mr. Barczak and Mr. Mascola in favor).**

**Motion: Mrs. Steenson motioned to approve resolution #2 which supports targeting 100% of any future New Hampshire state revenues derived from legalized gambling to the funding of public education. Mrs. Kosta seconded. With no further discussion the motion passed by unanimous vote 8-0-0.**

**Motion to amend: Mr. Bealo motioned to amend resolution #2 to read which supports targeting 100% of any future New Hampshire state revenues derived from legalized gambling to additional funding of public education. Mr. Barczak seconded. With no further discussion the motion to amend and the amended motion passed by unanimous vote 8-0-0.**

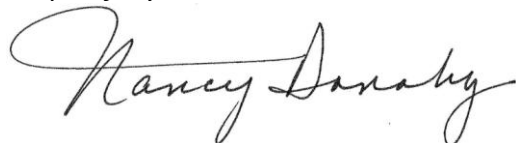
