

**MANSFIELD INDEPENDENT SCHOOL DISTRICT
RESOLUTION No. 26-19**

A RESOLUTION OF THE MANSFIELD INDEPENDENT SCHOOL DISTRICT (“DISTRICT”), TEXAS, AMENDING THE ORDER OF GENERAL ELECTION TO BE HELD ON MAY 2, 2026; DESIGNATING POLLING PLACES; ESTABLISHING ELECTION PRECINCTS WITHIN THE CITY; APPOINTING AN ELECTION JUDGE AND AN ALTERNATE ELECTION JUDGE; ESTABLISHING OTHER PROCEDURES FOR CONDUCT OF THE ELECTION; FINDING THAT THE MEETING AT WHICH THIS RESOLUTION IS PASSED IS OPEN TO THE PUBLIC AS REQUIRED BY LAW; AND DECLARING AN EFFECTIVE DATE

WHEREAS, Section 41.001 of the Texas Election Code (the “Code”) specifies that the first Saturday in May shall be a “uniform election date” and that a general election for political subdivisions may be held on such day; and,

WHEREAS, the Board of Trustees previously adopted an Order of Election on January 20, 2026, calling a general trustee election for May 2, 2026; and,

WHEREAS, the Board now desires to amend certain sections of that Order to conform to final joint-election arrangements, county election services, locations and schedules; and,

WHEREAS, by this Resolution, it is the intention of the Board to officially establish the election precincts, to designate polling places for the election, to appoint the necessary election officers, to establish and set forth procedures for conducting the election, and to authorize the District to enter into a contract with Tarrant County, and Johnson County to conduct the election.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF TRUSTEES OF THE MANSFIELD INDEPENDENT SCHOOL DISTRICT THAT:

SECTION 1.

GENERAL ELECTION CALLED: A general election shall be held on Saturday, May 2, 2026, for the purpose of electing TRUSTEE PLACE 6 and TRUSTEE PLACE 7. The election shall be conducted from 7:00 a.m. to 7:00 p.m. on Election Day.

SECTION 2.

TERMS OF OFFICE: Trustees elected at this election shall serve the term and stagger as provided by District policy and applicable law.

SECTION 3.

ELIGIBILITY FOR CANDIDACY AND BALLOT ACCESS: Candidate eligibility and filing requirements shall be as provided by law, with candidate materials available on the District’s website at <https://www.mansfieldisd.org> and the District’s designated filing office at 605 E Broad St, Mansfield, TX 76063.

SECTION 4.

JOINT ELECTION; COMMON POLLING PLACES: This election shall be conducted as a joint election with other political subdivisions using common polling places, as authorized by Texas Education Code § 11.0581 and Texas Election Code Chapter 271. The Superintendent or designee is authorized to execute a joint-contract agreement consistent with applicable law.

SECTION 5.

AGREEMENT WITH TARRANT COUNTY AND JOHNSON COUNTY: The District anticipates that it will enter into an agreement for election services with Tarrant County and Johnson County as authorized by Texas Election Code § 31.092. The Superintendent or designee is authorized to execute all such contracts and related documents. Further, The Board appoints Rebecca Wright as its Early Voting Clerk who is authorized to conduct early voting in the absence of an agreement for election services with any of the aforementioned counties.

Pursuant to Texas Election Code § 83.033, the Board, as the authority appointing the Early Voting Clerk, hereby authorizes the Early Voting Clerk to appoint one or more Deputy Early Voting Clerks as necessary for the proper administration of early voting. Such appointments shall not require further action of the Board and shall remain effective for the duration of the election and any resulting runoff.

SECTION 6.

ELECTION DAY POLLING LOCATIONS: On Election Day, District voters shall be served by the countywide vote centers or polling places designated by the counties pursuant to Texas Election Code § 43.007 and the joint-election agreements.

The Tarrant County Election Day Vote Centers serving the District are listed in Exhibit A, which is attached and incorporated by reference.

The Johnson County Election Day polling place serving the District is listed in Exhibit B, which is attached and incorporated by reference.

Locations are subject to county change; any change will be noticed as required by law.

SECTION 7.

EARLY VOTING: That early voting by personal appearance for Tarrant shall be conducted by the Election Offices in accordance with provisions of the respective agreement. Early voting by

personal appearance for Johnson County shall be conducted by the Early Voting Clerk for Mansfield ISD in accordance with State Law.

B. Early voting will be held as follows:

***Early Voting will not take place on April 21, 2026, San Jacinto Day, as it is a legal state holiday. ***

Tarrant County Voters

Tarrant County early voting locations and hours are set forth in Exhibit C, which is attached to this Order and incorporated by reference.

Johnson County Voters

Johnson County early voting locations and hours are set forth in Exhibit D, which is attached to this Order and incorporated by reference.

C. Early voting, both by personal appearance and by mail, shall be canvassed by the Early Voting Ballot Board, which is hereby created. The Presiding Election Judge and Alternate Election Judge will be appointed as provided below, as permitted by law. The Presiding Judge shall appoint election clerks as may be necessary for the proper conduct of the election. The Presiding Election Judge, or the Alternate Election Judge, in the absence of the Presiding Election Judge, and the election clerks, shall constitute the Early Voting Ballot Board to process early voting results from the election.

SECTION 8.

APPOINTMENT OF ELECTION JUDGES AND ALTERNATE ELECTION JUDGES – TARRANT COUNTY AND ELLIS COUNTY: Election judges for the general election shall be appointed by Tarrant County as authorized by Chapter 271, of the Texas Election Code.

APPOINTMENT OF ELECTION JUDGES AND ALTERNATE ELECTION JUDGES – JOHNSON COUNTY: The following-named individuals are hereby appointed to serve as Presiding Election Judge and Alternate Presiding Election Judges, respectively, at the election:

PRESIDING JUDGE

Dennis Slatton

ALTERNATE PRESIDING JUDGE

Josie Smith

The Election Judges and Alternate Presiding Judges shall be qualified voters of the District.

SECTION 9.

EARLY VOTING BY MAIL: Application for early voting by mail ballots by voters qualified to vote by mail shall be made to the Early Voting Clerk as follows:

Applications for ballots by mail (ABBM) and federal post card applications (FPCA) must be received no later than the close of business on April 20, 2026.

Ballot carrier envelop return requirements shall be as provided by law and county instructions.

SECTION 10.

METHOD OF VOTING: That a voting system or systems meeting the standards and requirements of the Texas Election Code, as amended, is hereby adopted and approved for early voting by personal appearance and by mail and for election day voting. The Board hereby adopts the ES&S Express Vote Marking Device for early voting and Election Day. All expenditures related to this election, including materials, equipment, and employment of all election officers, are authorized and shall be conducted in compliance with the Texas Election Code.

SECTION 11.

GOVERNING LAW AND QUALIFIED VOTERS: The election shall be held in accordance with the Constitution of the State of Texas and the Code, and all resident qualified voters of the District shall be eligible to vote at the election.

SECTION 12.

NOTICE OF ELECTION: Notice of the election shall be given in accordance with the provisions of the Texas Election Code, as amended.

SECTION 13.

RUN-OFF ELECTION: In the event no candidate receives a majority of votes for an office, there shall be a run-off election held on Saturday, June 13, 2026.

SECTION 14.

NECESSARY ACTIONS: The Board President, Superintendent, and their designees (including the Early Voting Clerk) are hereby authorized and directed to take any and all actions necessary to

comply with the provisions of the Code in carrying out and conducting the election, whether or not expressly authorized herein.


