**RESOLUTION OF THE BOARD OF TRUSTEES
OF THE SOUTH SAN FRANCISCO UNIFIED SCHOOL DISTRICT
AUTHORIZING LEASE OR PURCHASE OF RELOCATABLE MODULAR CLASSROOM
STRUCTURE FOR SOUTH SAN FRANCISCO HIGH SCHOOL
PURSUANT TO PUBLIC CONTRACT CODE SECTION 20118**

WHEREAS, the South San Francisco Unified School District ("District") desires to procure a Relocatable Modular Classroom for South San Francisco High School ("Relocatable Structure") in a cost-effective manner;

WHEREAS, pursuant to Public Contract Code section 20111, a school district is required to competitively bid "[t]he purchase of equipment, materials, or supplies to be furnished, sold, or leased to the district," that exceed \$114,800";

WHEREAS, Public Contract Code section 20118 is an exception to this requirement and states:

Notwithstanding Sections 20111 and 20112, the governing board of any school district without advertising for bids, if the board has determined it to be in the best interests of the district, may authorize by contract, lease, requisition, or purchase order, any public corporation or agency, including any county, city, town, or district, to lease data-processing equipment, purchase materials, supplies, equipment, automotive vehicles, tractors, and other personal property for the district in the manner in which the public corporation or agency is authorized by law to make the leases or purchases from a vendor. Upon receipt of the personal property, if the property complies with the specifications set forth in the contract, lease, requisition, or purchase order, the school district may draw a warrant in favor of the public corporation or agency for the amount of the approved invoice, including the reasonable costs to the public corporation or agency for furnishing the services incidental to the lease or purchase of the personal property, or the school district may make payment directly to the vendor. Alternatively, if there is an existing contract between a public corporation or agency and a vendor for the lease or purchase of the personal property, a school district may authorize the lease or purchase of personal property directly from the vendor by contract, lease, requisition, or purchase order and make payment to the vendor under the same terms that are available to the public corporation or agency under the contract.

WHEREAS, the District wishes to procure a Relocatable Modular Classroom by utilizing an existing contract between a public corporation or agency and a vendor;

WHEREAS, the Hesperia Unified School District ("HUSD") published a notice for bids for the purchase of portable classrooms; obtained a bid from Silver Creek Modular ("Vendor"); and awarded the contract ("Piggyback Contract") to Vendor on November 8, 2021, which HUSD subsequently extended through November 2022, November 2023, November 2024 and November 2025;

WHEREAS, the Piggyback Contract includes a provision, pursuant to Public Contract Code section 20118, allowing other public agencies, including the District, to procure the Relocatable Structure from the Vendor under the same terms and conditions of the Piggyback Contract; and

WHEREAS, the District staff has researched the costs and terms of the Piggyback Contract and believes that the prices under the Piggyback Contract are reasonable and that it is in the best interests of the District to utilize the Piggyback Contract to procure the Relocatable Structure from Vendor.

NOW THEREFORE, the Board of Trustees of the South San Francisco Unified School District hereby finds, determines, declares, orders, and resolves as follows:

1. That the foregoing recitals are true.
2. That the Board of Trustees hereby declares that it is in the best interests of the District to procure the Relocatable Structure from Vendor via the Piggyback Contract.
3. That the Board of Trustees hereby authorizes the District's Superintendent and/or designee to take all further action necessary to otherwise carry out, give effect to, and comply with the terms and intent of this Resolution.


