2. Describe the host’s educational oversight to ensure students with disabilities are educated in the least restrictive environment while in the 1306 facility? (If not a host, answer as if you were.)

The district serves as the host for students who are placed in a residential home for medically fragile children. The district provides medical supports and services within the school setting to ensure that the students can participate with non-disabled peers to the extent appropriate. The district ensures that students are receiving FAPE through full implementation of the evaluation and IEP process. When students are placed in the residential facility, the District has little to no notice, which presents unique challenges when programming for such needs. Additionally, the district has difficulty obtaining student records. The District LEA works quickly and efficiently to seek these records so that we can provide a pendant IEP and convenes a team within a reasonable amount of time (not to exceed 30 days) after the student transitions to discuss further the services, supports that are needed to support the student. When the District is alerted by the 1306 facilities that eligible students are residing within the Pottsgrove School District, the District reaches out to these facilities to begin the process of ensuring that an appropriate program and placement are offered. For students who are suspected but not yet identified as children with disabilities, the District begins the evaluation procedures as set forth by federal and state law. The District ensures that it meets the Least Restrictive Environment obligation by first considering the option of providing the student with his or her education at the regular district school located in closest proximity to the institution where the student is residing. In circumstances where the student's placement at a regular district school is not appropriate or is prohibited by the terms of his/her placement at the institution, the District works to ensure that the education provided at the institution itself is as nonrestrictive as possible. Student instruction is discussed by the IEP team and we ensure that the student receives instruction from a special education teacher either at the facility while placement is sought or in a placement that provides instruction by special education teachers.

3. Describe the School District’s procedures for communicating with 1306 facilities and how the district ensures a successful transition back to school.

The District communicates directly with the nursing lead coordinator at the pediatric residential facility. LEA hosts IEP meetings with this individual and attempts are made to engage the families as well. IEP meetings occur to discuss students ongoing needs and when and where appropriate transition discussions occur. In order to avoid barriers, the District has instituted a streamlined process of communication. Communication with the District's registrar and the Special Education Department occurs on a monthly basis to ensure that newly registered 1306 students are brought forward immediately. Ongoing communication between the 1306 facilities and the Special Education Department does occur frequently to avoid any gap in the delivery of services for students identified under IDEA. When a student is deemed ready to return to school the District schedules an IEP meeting with the facility and the school based team to ensure a successful transition.

Summary In summary, Pottsgrove School District's performance in LRE data shows relatively stable placement of students in the Least Restrictive Environments over the years. The percentage of students receiving itinerant levels of support (80%+ time in general education) has consistently shown a steady increase, while the notable dip in 2023, reflected an increase of students in settings with less than full inclusion. Overall LRE data shows that the district is moving in the right direction. We continue our efforts to expand least restrictive placement and service options both in and out of district for our students.

4. What universal practices does the School District utilize to address the academic and social/emotional needs of all students in need of accommodations to their learning environments?

The Pottsgrove School District ensures that children with disabilities are educated to the maximum extent possible with non-disabled children through the Individualized Education Plan (IEP) development process. The district strives to ensure that the process of identifying the least restrictive environment is followed by providing extensive modifications, adaptations, behavioral interventions, and reevaluations prior to moving a student to a more restrictive placement. Students' specific needs are identified through a comprehensive evaluation which is completed by a multi disciplinary team. The District is committed and actively working to further develop and enhance the multi-tiered systems of support framework district-wide. Cross-disciplinary teams represented at the district, school, grade and individual levels use a problem-solving process to integrate evidence-based academic, behavioral and social-emotional practices matched to student needs and with fidelity of implementation. A continuum of support and services exists at all Tiers and is sustained by high-quality professional learning, cultural responsiveness,

partnership and meaningful involvement with families, and dynamic decision-making that rests on the use of reliable and valid data sources. Sustainability (transformational change) is the ultimate implementation goal of a Multi-Tiered System of Support (MTSS) and is very much contingent upon Leadership, Organization and Competency. District, building, grade-level, and individual problem-solving teams continuously collaborate. With an on-going process of collecting and analyzing data, teams make decisions to enhance student outcomes. At all levels, teams evaluate the efficacy and efficiency of district-wide and school level implementation and review student progress and make decisions about instruction. The District also works to ensure that identified students are educated to the maximum extent possible with non-disabled peers in the general education setting. In addition paraprofessional supports are provided when a special education teacher is not available as deemed appropriate by the IEP team. These supports address academic, social-emotional and physical needs per student IEP plans. In addition the District provides trainings on inclusive practices, Restorative Practices, MTSS/CST, Second Step, school wide PBIS systems, and Responsive Classroom. Over the last 2 years the district has had a focus goal on implementing and developing co-teaching practices K-12. We continue to expand these efforts. Additionally, we have one of our buildings in year 2 of whole building implementation of the Universal Design for Learning framework. Into the coming years we are looking to expand these efforts.

5. Describe the academic programming and training efforts the School District utilizes to ensure meaningful participation of students with disabilities in the general education curriculum.

The District provides a continuum of services K-12. All staff receiving ongoing training on supporting teachers in the general education environment through accommodations and modifications of the content. All staff K-12 have also been trained in Differentiated Instruction, and will continue to be trained on Inclusive Practices, and supporting meaningful and purposeful student access and engagement in the general education curriculum. The district has a full continuum of special education services. The district provides services to students in the general education curriculum through a number of supported classrooms. In the past few years, there has been greater emphasis on providing in-district professional development for special education and regular education teachers together so they can learn additional instructional strategies to meet student needs and well as provide opportunities for special and regular education teacher to work on the development of the curriculum. Paraprofessional training has been enhanced in recent years to include training on topics such as de escalation, trauma informed approaches, and behavioral interventions. The school district has an ongoing commitment to positive behavior practices and other initiatives with the participation of both special and general educators to share effective instructional practices in all settings. The District has also developed and shares with all paraprofessional staff the expectations for student interactions and methods to maintain highly qualified status. Teachers and other professionals receive training on the development of the IEP, postsecondary transition, and providing effective support to students receiving

secondary/post 12 services. Over the last 2 years the district has had a focus goal on implementing and developing co-teaching practices K-12. We continue to expand these efforts. Additionally, we have one of our buildings in year 2 of whole building implementation of the Universal Design for Learning framework. Into the coming years we are looking to expand these efforts. The District's Director of Pupil Services is a newly trained FAB (Framework for Access and Belonging) Facilitator. The District is looking at further building capacity and training additional staff members to support the IEP teams who require this process be implemented.

6. Describe the supplementary aids and services the LEA utilizes to ensure meaningful participation of students with disabilities in extracurricular activities.

IEP teams ensure meaningful participation of students with disabilities in extracurricular activities by engaging in conversation at IEP meetings relating to the educational placement question related to this topic. Teams consider all relevant types of supplementary aids and services in order to ensure that students can meaningfully participate (collaborative, instructional, physical, social-behavioral). As needed, this can include, but is not limited to, the use of paraprofessional support and/or peer mentors. Students in out of district placements are also given information on extracurricular activities and events with the intent to support their participation where and when interested. We have also been expanding the opportunity for Unified Sports at our high school and are piloting Special Olympics and Unified Sports at our elementary schools this spring and into the 2026 and 2027 school years. These inclusive, purposeful opportunities for peers with and without disabilities coming together has built the mindset of belonging and inclusion district wide.

7. Describe the School District procedures that ensure, to the maximum extent appropriate, children with disabilities placed in private institutions are educated with non-disabled children and have the opportunity to participate in district-led extracurricular activities.

All students placed in private institutions are allowed to participate in District-wide activities. Transportation is provided by the District from the private institution to the district-site. District newsletters and district-wide announcements are included on the District website, on social media platforms.

8. Discuss the School District's need to build capacity and expand programs and services in an effort to provide a continuum of services. (Consider the out-of-district placement chart).

The District is working to provide a continuum of services for students within the Pottsgrove School District. While we support an inclusive model we recognize the need for options for learners who may require a different intervention within their school setting. The District has partnered with PaTTAN the MCIU in an effort to further coach, consult and collaborate on the programs and services offered in the district and how we can further develop and enhance to meet all of the unique learners needs. In addition the district is analyzing current students placed outside of the school district in an effort to transition students back to programming within their

home district. In order to support this transition capacity in both the general education and special education teachers is essential. We have expanded our offerings of post 12 and job/career opportunities for students with the addition of a transition coordinator role at our high school. This individual has been expanding our offering of post 12 and work/job experiences in our local community. We have also worked to expand the offering of emotional supports by developing itinerant and supplemental/full time classrooms staffed by full time teachers at our K-2 and 3-5 elementary schools. In addition at our middle school and high school we have developed an alternative education program during the day and in the Evening to provide students with emotional support needs services within the regular school building. This allows us to minimize further out of district and more full time levels of support and service.

9. How does the School District support the emotional, social needs of students with disabilities?

Pottsgrove School District is implementing the Multi-Tiered Systems of Support framework including the framework of Positive Behavior Interventions and Supports. Buildings are working within the consortium supported by the MCIU TAC teams to implement with fidelity. The district is actively working with PaTTAN and the MCIU to receive technical assistance to re-assess and further implement social and emotional learning approaches with fidelity. Building-based teams are using data to ensure implementation with fidelity as well as build protective factors for students. Aside from universal supports, the district is continuing to build Tier II and III services for at-risk students. The district currently has a Coordinator of Special Services (is a BCBA) who further supports behavioral programming across the district. There is also two additional district wide BCBA's (supporting elementary and secondary), and 10 RBT's. Their work includes: using antecedent strategies, checking for fidelity of implementation; collecting behavioral information to make data informed decisions; providing training to staff in implementation of behavior plans; conducting FBA's (Functional Behavioral Assessments). Additionally, the district is mapping out the resources at each level to determine if other supports are needed for students. The district also provides a number of preventive services related to bullying, suicide, and student coping. The district has ongoing training with building-based crisis teams regarding de-escalation techniques. Staff across the district have participated in professional development given by the District's BCBA in de-escalation strategies and techniques including restorative practices. Pottsgrove has also partnered with Hopewell Counseling and their HOPE program that provides 4 doctorate level clinicians who are at all 3 Elementary buildings and the 1 middle school providing in house therapy services for identified students, staff development in areas of need in relation to the students mental health needs and can also provide services to identified families outside of school . At our High school we added a Drug and Alcohol Counselor in the 2025-2026 school year to support with connecting students to individual and group counseling support in these areas. They also connect families and students to outside mental health services.

10. Describe training provided to staff in the use of positive behavior supports, de-escalation techniques, and responses to behavior that may require immediate intervention.

Throughout the district there are 3 BCBA's and 11 RBT's who provide support in implementation and training school staff in implementation of PBSP's. Teams have at minimum of bi weekly

meetings to discuss student behavior and to review positive behavior support strategies for students with PBSP's. In addition, BCBA's provide trainings to paraprofessionals in general antecedent strategies to use with students, ABA best practices and understanding the functions of behaviors and matching interventions. Building administrators, teachers, specialists and paraprofessionals are trained at least one time throughout the year on verbal de-escalation and trauma-informed care by the district's BCBA's and RBT's. All buildings have trained Safety Cares teams that are trained annually in verbal de escalation and as a last resort use of restraints. Safety Care teams meet monthly or bi-monthly to review procedures and work through building specific needs. Additionally, teams meet to debrief after any major behavioral incident to see where improvements are needed, plan for additional behavioral support and to talk about what worked well. The District has also supported focused training in partnership with the MCIU and PaTTAN in restorative practices this included administrative and building staff.

11. Describe the School District's positive school wide support programs.

The district is actively working with MCIU to receive technical assistance to re-assess and build the PBIS framework and move from Tier 1 to Tier 2 fidelity. Building-based teams are using data to make sure the programs are operating with fidelity as well as build protective factors for students. Currently all buildings K-8 have been recognized by the state network for PBIS as implementing with tier 1 fidelity. K-5 teams are working towards advanced tier training and recognition in the coming years. Across the district all buildings follow the Falcon 4 as part of their PBIS model; be safe, be positive, be respectful and be responsible. Pottsgrove High School has begun to develop a core team and is working with the MCIU TAC's to develop their framework for MTSS/PBIS.

12. Describe the School District's school-based behavior health services.

Each building has a Student Assistance Program (SAP) and/or Elementary Student Assistant Program (ESAP) and they meet weekly or bi-weekly with a representative liaison from Creative Health Services. The SAP/ESAP team assists families with connecting to community based mental health services, some students get MH3 services in the school setting and the SAP teams develop interventions to assist the student in the school (check in check out, mentors, etc) on a bi-weekly basis. Pottsgrove has also partnered with Hopewell Counseling and their HOPE program that provides 4 doctorate level clinicians who are staffed K-8. They provide in-house therapy services for identified students, staff development in areas of need in relation to the students mental health needs and can also provide services to identified families outside of school . Across the district in K-8 , teachers are using the 2nd Step curriculum to teach social skills and as a SEL curriculum. In 9-12 we are using ReThinkEd as the tiered intervention and curricular resource.

13. Describe the School District's restraint procedure.

Restraints are used as a very last resort after all efforts to attempt verbal de-escalation have not been successful and the student poses imminent risk of harm to self or others. After there has been a restraint the family is notified, the student and staff are checked out by the nurse, teams

debrief, the team completes a restraint report, an IEP Meeting is offered to the family and the IEP team meets to discuss the incident and make adjustments as needed to the PBSP. There are two in house de-escalation/restraint trainers who provide both the restraint and the de-escalation only trainings to staff where needed. Each building has a trained de-escalation/restraint team in the Safety Care model to support students. When restraints are used, the student is examined by a school nurse, the district must notify the parent that day, and then hold an IEP meeting within 10 days (unless the parent waives the need for a meeting formally). All written documentation and special education documents are sent to the special education department for filing and documentation in the Department of Education website.

Intensive Interagency

Please address any areas of concern with students who are placed on Instruction Conducted in the Home or who are at a substantial risk of waiting more than 30 days for an appropriate educational placement.

To date, the district has had difficulty ensuring FAPE for 2-3 students over the last year and a half. Students that need higher intensive medical and/or behavioral support may need an outside placement. Pottsgrove School District does offer a continuum of placement offerings and we attempt to support students in these environments before seeking an intensive multiple disabilities classroom, therefore, these students are placed at our intermediate unit or one of our out of district placements providers. With the number of students in the surrounding counties that are also in need of placement, the school district has seen a waitlist for various placements making it difficult to ensure FAPE. In these cases, the district has reached out to MCIU intensive interagency service to help with placement of these students. The district continues to focus on recommending placements for students in the least restrictive environment. The district has developed partnerships with local law enforcement, juvenile probation officers, Children, Youth, and Families, local mental health providers, local providers for students with intellectual disabilities, and the Office of Vocational Rehabilitation (OVR). Pottsgrove uses services provided through PaTTAN to facilitate interagency meetings involving outside agencies to collaborate and provide support for the student and family. The District has used the interagency approach successfully to work with outside agencies, private experts, and parent advocates. If a particular building on campus does not have a program or peer group, students have moved from the home school to another school within the district or a cross-district school before considering an out-of-district placement. These options allow for placement in programs that allow access to typical peers for the purposes of ensuring a least restrictive environment. Currently, when outside placements are necessary, the most difficult placements have been for young students with extreme mental health/behavioral needs. Functional Behavior Assessments are conducted and Positive Behavior Support Plans are implemented for these students prior to a change of placement. Additionally, our BCBA works with the staff to train and coach the implementation of behavior plans to ensure fidelity of implementation.
