Subject	10.02 BloomBoard, Inc. (Human Resources/Finance) - RESOLVED, that the Board of Directors of the School District of Pittsburgh authorize its proper officers to approve a contract with BloomBoard, Inc. ("BBI) to facilitate the PPS Educator Registered Apprenticeship Program by utilizing the BBI Platform and their established Educator Advancement Program. The program will assist PPS in its efforts to recruit, develop, and retain highly qualified staff, with a focus on promoting equity by ensuring that the PPS teaching workforce reflects students' racial and linguistic diversity. BBI will assist PPS with the development of the apprenticeship program application, PA Department of Labor and Industry review and approval, and registered technical instruction components. The contract period will run from October 1, 2025 through September 30, 2027 to coincide with the CTRA Apprenticeship Grant period. The contract cost of \$375,000 will be payable in two installments (November 1, 2025 and March 1, 2026 of \$187,500 each) with \$240,000 to be reimbursable from the CTRA grant. The account lines for this contract are \$240,000 to 001-2800-1PR-2272-566-900-00-000-0000 and \$135,000 to 000-2800-010-2272-566-100-00-000-0000.
