Notice is hereby given that the Northern California School Nutrition Purchasing Cooperative (“[NorCal SN Co-op](#)”, “Co-op”) in the State of California is requesting proposals from qualified vendors for delivery of food and supplies for the 2026-27 school year. Members include eleven Public School Districts, namely: Bellevue Union SD, Calistoga Joint Unified SD, Healdsburg USD, Novato USD, Old Adobe Union SD, Petaluma City Schools, San Rafael City Schools, Sonoma Valley USD, St. Helena USD, Tamalpais Union HSD, Windsor USD. RFPs will be awarded based on price and scoring criteria from responsive and responsible vendors. Evaluation criteria are; Pricing, Delivery Characteristics, Buy American (and related) Reporting, Local Geographical Content, Ordering Process, Substitution Protocol, Accounts Receivable, Commitment to Sustainability, UPF Elimination, Service Reliability, and Piggybacking. The NorCal SN Co-op shall be the sole judge in determining the quality and appropriateness of the products, supplies, or services proposed. Its decision shall be final.

Proposals shall be received, up to and not later than the date and time stated above, electronically, or at the Business Office, Tamalpais Union High School District, 395 Doherty Drive, Larkspur, CA 94939. All proposals received on or before this date will be accepted. All vendors will be responsible for obtaining any addendums or revisions to the project.
