February 11, 2026	REGULAR BOARD MEETING, 6:00 pm. Approval of the 2026-27 Budget Calendar Review Open Budget Committee Vacancies
May 8, 2026	Publish first Notice of Budget Committee Meeting. If publishing in a newspaper and local government's website, the newspaper notice must be published 5 to 30 days before the meeting and must include the website address where the notice must be published at least 10 days before the meeting. <i>ORS 294.426(5)(b).</i> Due to the News Register May 6, 2026; Amity School District Website May 8, 2026
May 13, 2026	REGULAR BOARD MEETING, 6:30 pm
May 20, 2026	FIRST MEETING OF THE BUDGET COMMITTEE 6:30 pm Amity District Office. A budget committee must have a quorum, or majority of the total membership of the committee, present in order to hold a meeting. <i>OAR 150-294.0450</i> Elect presiding officer. <i>ORS 294.414(9)</i> Budget committee may choose to elect an alternate presiding officer. Present the budget message by the executive officer and the budget document by the budget officer. The budget document is filed in the district office as a public record, and a copy of the document or part thereof is made available to any person requesting it. Receive questions and comments from citizens. Announce time and place of the next meeting. Additional meetings not published in the original Budget Committee notice must be advertised as a notice of meeting of government body. <i>ORS 294.426</i> All meetings shall be open to the public. <i>ORS 294.428(2)</i> The committee may demand and receive any information it requests and compel the attendance of any employee at its meetings. <i>ORS 294.428(3)</i> A majority of the members of the budget committee is required to pass any motion. <i>ORS 174.130</i>
May 27, 2026	Second Budget Committee Meeting, 6:30 pm (if needed) Public Hearing on the Budget, as approved by the budget committee, shall be conducted by no less than a quorum of the board.
June 12, 2026	Publication of the Notice of Budget Hearing (ED1), not more than 30 days nor less than 5 days prior to the hearing. <i>ORS 294.448</i> Due to News Register June 10
June 24, 2026	REGULAR BOARD MEETING, 6:30 pm. Final adoption of budget, resolutions and appropriations by the board of directors.
July 15, 2026	Deadline to certify the tax levy (ED 50) to the county assessor or to request an extension. <i>ORS 310.060(1)(7)</i> Note: Any municipal corporation requesting an extension of time as allowed in <i>ORS 310.060</i> , shall state in writing the reason for the request and whether or not a bonded debt levy will be required. Deadline to submit complete budget document to State Superintendent of Public Instruction. <i>ORS 326.310(4)</i>
