Attendance is limited for reasons of security, safety, or control.

2. () Open Site: Serves all children through age 18 at a site that is located within the geographical boundaries of the attendance area of an OCSD school where at least 50% of the children are certified eligible to receive free or reduced price school meals.

3. () Closed Enrolled Site: Serves only an identified group of enrolled children who are participating in a specific program or activity (in area eligible or non-area eligible locations); these sites are not open for area children to "drop in" for meals and site activities. To qualify as a "Closed Enrolled" site that is not "area eligible," at least 50% of the children are certified eligible to receive free or reduced-price school meals.

4. () Residential and Non-Residential Camp: Organized program for enrolled children who are participating in a specific program or activity (in area eligible or non-area eligible locations); these sites are not open for area children to "drop in" for meals and site activities.

5. () Migrant Site: A type of open or restricted open site. OCSD must certify that migrant sites only serve or primarily serve children of migrant workers. Determination of site eligibility is required through a migrant coordinator or a migrant organization.
