**Resolution Proclaiming Fair Housing Week in Dodge County  
(April 5, 2026 – April 11,2026)**

TO THE HONORABLE BOARD OF SUPERVISORS OF DODGE COUNTY, WISCONSIN:

**WHEREAS**, it is important to reaffirm the commitment of Dodge County regarding citizens’ right to buy, sell, rent or otherwise secure housing in Dodge County without regard to sex, race, religion, marital status, age, national origin, income or financial status in conformance with Title VIII of the Civil Rights Act of 1968 a/k/a the Federal Fair Housing Law and State Open Housing Law; and,

**WHEREAS**, fair housing occurs when people have a wide range of housing choices based on their income and needs regardless of race, color, sex, sexual orientation, religion, national origin, ancestry, age, marital status, lawful source of income, disability, family status or status as a victim of domestic abuse, sexual abuse or stalking;

**NOW, THEREFORE, BE IT RESOLVED**, that the Dodge County Board of Supervisors does hereby proclaim April 5, 2026 – April 11,2026 to be Fair Housing Week in Dodge County; and,






