PLEASE PRINT CLEARLY.

This application may only be used for school district votes by qualified voters who reside in a school district that provides for personal registration of voters. If the application requests the absentee ballot be mailed, the application must be received by the District Clerk, 160 Van Wyck Road, Blauvelt, NY 10913, not later than 7 days before the vote for which the absentee ballot is sought. Otherwise, the application may be personally delivered to the District Clerk not later than the day before the vote. Applications may not be submitted more than 30 days prior to the vote. If you are qualified for early mail voting and issued an early mail ballot, the ballot itself must be received by the District Clerk by 5 PM on the day of the vote (May 19, 2026) in order to be canvassed.
