Bids shall be delivered and received by the School District at the above stated address no later than 1:00 p.m. prevailing time, on Wednesday, April 22, 2026, and the bids will be opened at 1:30 p.m. on Wednesday, April 22, 2026. Bids shall be submitted in sealed envelopes bearing the name of the Bidder and shall be clearly marked "New Passenger Van".

The School District reserves the right to accept or reject any or all bids, to waive any technical defects, inconsistencies, or minor irregularities, and to accept the bid deemed most advantageous to the School District.

The successful bidder will offer for purchase to the Connellsville Area School District one (1) New 2026 Chrysler Pacifica Select All-Wheel Drive Passenger Van (Bright White Color) satisfying and meeting the following minimum Specifications, deliverable to the District or at a mutually agreeable location within five (5) miles of the District Administration Building within one (1) week of the School District's acceptance of the bid and submission of an order:

1. New/unused vehicle;
2. Bright white color
3. Less than 500 miles;
4. Standard features;
5. Standard bumper-to-bumper and powertrain warranties;
6. No defects; and
7. Full tank of gas.

Bidder shall provide a copy of all other specifications and features for any New 2026 Chrysler Pacifica Select All-Wheel Drive Passenger Van (Bright White Color) offered and an affirmation and certification that any New 2026 Chrysler Pacifica Select All-Wheel Drive Passenger Van (Bright White Color) offered in its bid meets or exceeds the above Specifications. The School District anticipates using the vehicle for student and staff transportation purposes.

The vehicle and its systems and components must meet and/or exceed manufacturer's recommendations, specifications, and applicable codes and requirements. The vehicle and its systems and components shall be under full warranty for a period of not less than any manufacturer warranty period. All information regarding any warranty shall be required, in writing, to be submitted as part of the bid submission.

Bidder shall be responsible for all taxes, duties, and other charges associated with the purchase of the vehicle and its systems and components or amounts paid under this bid or the corresponding contract award. The Connellsville Area School District notes that it is a tax-exempt governmental entity and, specifically, is exempt from the payment of sales and use tax.

By submission of a bid, Bidder certifies that it is currently (or will become prior to commencing any sale) registered and licensed to operate a business and sell the vehicle described in its bid within the Commonwealth of Pennsylvania and the Connellsville Area School District.

Bidder hereby offers to sell to the Connellsville Area School District the New 2026 Chrysler Pacifica Select All-Wheel Drive Passenger Van (Bright White Color) described in this Specifications and Bid Form based on the following costs:

INSTRUCTIONS

- 2.** This Non-Collusion Affidavit must be executed by the member, officer, or employee of the Bidder who makes the final decision on prices and the amount quoted in the proposal.
- 3.** Bid-rigging and other efforts to restrain competition, and making of false sworn statements in connection with the submission of proposals are unlawful and may be subject to criminal prosecution. The person who signs the Affidavit should examine it carefully before signing and assure himself or herself that each statement is true and accurate, making diligent inquiry, as necessary, of all other persons employed by or associated with the Bidder with responsibilities for the preparation, approval, or submission of the proposal.
- 4.** In the case of a proposal submitted by a joint venture, each party to the venture must be identified in the proposal documents, and an Affidavit must be submitted separately on behalf of each party.
- 5.** Failure to file an Affidavit in compliance with these instructions will result in disqualification of the proposal.
