**1. Call to Order**

**2. Act on the Articles of the Meeting**

● ***ARTICLE 1 To elect a moderator for a one-year term***

Ms. Canning opened the floor for nominations.

Mr. Cecchinelli II nominated Tom Koch, and Mr. Boutin seconded the nomination.

There were no additional nominees. Nominations were closed.

Nomination passed unanimously with those present.

**On a motion by Mr. Cecchinelli II, seconded by Mr. Boutin, the assembly voted to elect Tom Koch to serve as Moderator for a one-year term; the motion passed.**

● ***ARTICLE 2 To elect a clerk for a one-year term***

The Moderator opened the floor for nominations.

Mr. Boutin nominated Tina Lunt, and Mrs. Wheeler seconded the nomination.

There were no additional nominees. Nominations were closed.

Nomination passed unanimously with those present.

**On a motion by Mr. Boutin, seconded by Mrs. Wheeler, the assembly voted to elect Tina Lunt to serve as Clerk for a one-year term; the motion passed.**

● ***ARTICLE 3 To elect a treasurer and assistant treasurer for a one-year term***

With no objections, Mr. Koch indicated they would pass over the election of an assistant treasurer

The Moderator opened the floor for nominations for the treasurer position.

Mr. Boutin nominated Ashley Young, and Mr. Grant seconded the nomination

There were no additional nominees. Nominations were closed.

Nomination passed unanimously with those present.

**On a motion by Mr. Boutin, seconded by Mr. Grant, the assembly voted to elect Ashley Young to serve as Treasurer for a one-year term; the motion passed.**

● ***ARTICLE 4 To determine what compensation shall be paid to the officers of the District.***

**On a motion by Mr. Boutin, seconded by Ms. Wheeler Reynolds, the assembly voted to approve all salaries listed in Article 4 as printed below; the motion passed.**

- ***ARTICLE 5 Shall the voters of Barre Unified Union School District vote to authorize its Board of School Commissioners to borrow money, when needed, by issuance of bonds or notes not in excess of anticipated revenue for the school year, to meet the expenses and liabilities of the school district?***

**On a motion by Mrs. Wheeler, seconded by Mr. Boutin, the assembly voted to adopt Article 5, as presented; the motion passed.**

- ***ARTICLE 6 Shall the voters of the Barre Unified Union School District vote on all public questions by Australian Ballot?***

Did not act on this, Mr. Koch indicated that this Article will appear on the ballot tomorrow.

- ***ARTICLE 7 To do any other business, proper to come before said meeting***

Hearing none, Mr. Koch passed over.

- ***ARTICLE 8 To adjourn***

**On a motion by Mr. Boutin, seconded by Mr. Campbell, the assembly voted to adjourn at 5:39 p.m.**
