 - Creating more partnerships at other school - Ed Camp (DA: possibly in May)
 - Goal 3: ARC implementation

Collecting data

Budget:

We have a preliminary budget but nothing is final.

- In previous years we have been fortunate enough to spend money but due to rising costs, we need to make cuts this year. A little over \$253,000
- Mr. Anderson entered information in the budget book. He offered an explanation on how the budget book works.
- Question: The projection of 33 students less than in previous years, where are they going? Moves, etc.
- Question: Do they add to our budget if new students arrive? Working on what we have, they do not adjust the budget

Reviewed options for cuts to be made.

Questions:

Is webmaster a school based position or a portion for the main LPS website? School Based.

Is there a counter to track website traffic? Emily C. will check if it can be added

Translation stipend for bilingual paras? It was but it was only funded for one year then became school based funding.

Can paras get training to help compensate for tutor loss? Open for discussion

Statement: Losing the least amount of paras would be ideal
