Our WICOR and DOK professional development, as well as e3’s learning model, is starting to take shape and land with our scholars, which is being reflected in our test scores..</p> <p>Next, Dr. Taylor shared e3’s School-Wide Objectives as they relate to our LCAP to gather input from the council. Our 5 goals regard an Innovative Instructional Program, Community Schools, Scholar Engagement, Scholar Learning, and Employee Engagement. He then shared the LCAP Mid-Year Review.</p> <p>This covered the school’s performance towards achieving our goals and how much of the funding has been spent on each goal thus far in the school year. He then asked for input on what is going well within each goal and areas we improvement.
