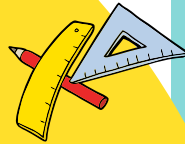

Math/Reading

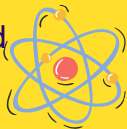


- Provides pull-out small group direct instruction, supplemented by consultation with the classroom teacher and/or push-in during small group instruction time in the general education classroom
- Administers diagnostic and benchmark assessments
- Targets skill remediation for students performing below grade level
- Emphasizes early intervention in primary grades (also available in upper grades)



Math/STEM Coach

- Provides training to teachers in the area of mathematics and STEM
- Coaches teachers to transfer best practices into classroom practices
- Provides resources relating to new techniques and practices in mathematics and the use of technology
- Assists teachers in specific matters of curriculum development, instructional strategies, and assessments in mathematics and technology



Special Needs Consultation

Consultation Services are provided to teachers in nonpublic schools to assist in educating students with special needs. Evidence that a student meets disability criteria must be presented. The consultant works with teachers to design appropriate accommodations for each student. The accommodations and/or specific strategies can focus on issues that are academic, social or behavioral.



School Counselor

- Provides classroom lessons based on: PA Career Ready Skills
 - Self-awareness & self-management
 - Establishing & maintaining relationships
 - Social problem-solving skills
 - College & career self-assessments, research & employability skills
- American School Counselor Association National Model
 - Developmentally appropriate curriculum focused on the mindsets & behaviors all students need for postsecondary readiness & success
- Collaborates with school staff to address student needs and promote a positive school climate.

Enrichment

- Provides challenging instruction to students who are excelling in the classroom
- Supports classroom teacher to meet the students' academic needs beyond the standard curriculum

Speech and Language

- Provided by PA-certified speech/language therapists
- Emphasis on early intervention in primary grades (also available in upper grades)
- Provides individual and/or small group instruction to students with speech and/or language difficulties
