Sharon Wright was absent. Also in attendance were Superintendent Mr. Daniel Street, Elementary Principal Tyna Morrison, Athletic Director Angie Stone, and SpEd Director Nicole Kelly. Parents Poet and Carie Sanders were also in attendance, along with community member/grandparent Donnie Cox, community member/Vendor Steven Calton, educators Traci Heussner and Johnna Dunwoodie, with seniors Khloe Rogers and Corbin McBee.
