**ALTERNATE BUS STOP REQUEST FORM**

**\*\*Form must be submitted to the Transportation Office by August 1, 2026 to begin on the first day of school.**

Your child is assigned to the bus stop closest to your residence. All transportation is automatically determined to be to and from home. Parents/guardians may request an alternate bus stop location other than the residence by submitting this form. Requests for a change of route / stop location will only be considered when the following conditions are met:

1. The student's residence is eligible for transportation and the student would not normally be a "walker";
2. The bus stop must be a residence, not a local daycare.
3. The proposed stops are within the attendance area of the student's assigned school;
4. The stops are or can be located on the existing routes of the student's assigned school;
5. The request is made for a five day a week basis, not on a rotating schedule, and with the intent that the transportation arrangements requested would be for the full year;
6. The morning and afternoon (AM & PM) alternate bus stop location must be the same;
7. Space availability, if the requested alternate bus stop is on a different route than residence route.

This form must be received in the transportation office before August 1, 2026, for the request to begin on the first day of school.

**Requests received:**

- between 08/02/26 to 09/01/2026 will go into effect on September 15, 2026
- after 9/01/26 will go into effect 2 weeks after the form is received

**Changes to the initial request on the Alternate Bus Stop Form will not be accommodated during the school year.** The alternate bus stop will be the permanent stop for the remainder of the school year. Appeals to this policy must be made in writing to the Superintendent, or his/her designee, and the request will be reviewed and may be approved by the Superintendent after Board review.

Alternate transportation arrangements are made available as a courtesy. **These arrangements must be for 5 days per week and to the same address for both the AM & PM stops and are only permissible when there is room on the bus. (Policy 8600).** The district has the final decision on if this form is approved. Factors being considered: bus occupancy, location of alternate stop, existing routes and stops, etc.
