**SUPERINTENDENT'S REMARKS (NO ACTION / REPORT ONLY)**

Dr. Saul Hinojosa, Superintendent of Schools, addressed the Board and audience recognizing Dr. Abelardo Saavedra, TEA, as today is his last Board meeting as our Conservator. He stated that Dr. Saavedra has served as Superintendent, Monitor and now Conservator. He stated that Dr. Saavedra was a mentor to him. He said that Dr. Saavedra worked with our Board of Managers for over a year now. He said he knows that Dr. Saavedra's

heart has been here with South San for years. The Board President Mr. Tijerina presented him with a personalized plaque and Dr. Saavedra received a standing ovation. Dr. Hinojosa continued on with his remarks stating that today was our first day back from the break and we are planning for the last stretch of the school year. He stated that teachers are the foundation of our school system and they work very hard to make sure the students receive the best education possible. 
