The regular meeting of the Monroe-Gregg Board of School Trustees began with the Pledge of Allegiance.

**CALL TO ORDER**

The meeting was called to order by School Board President, Mr. Brock Sears, at 5:31 P.M. in the Administration Office. Board members in attendance included Mr. Jack Elliott, Mr. Tom Kennedy, and Mr. Ky Kizzee. Superintendent, Mr. Trent Provo and School Board Attorney, Mr. Steve Harris, were present. MGTA representatives, Mrs. Casey Honkomp, and Mrs. Julie Dimmack were also present. Mr. Kevin Blundell was not in attendance.

**PUBLIC COMMENTS**

There were no public comments.

**CONSIDERATION OF BID AWARD FOR FACILITY MANAGEMENT SERVICES**

Mr. Provo asked that the board approve the recommendation to award the project to GSF Cleaning and Support Services for \$749,973.67 which was the lowest bid. At the March 9<sup>th</sup> board meeting, there was a recommendation by the board to table the agenda item in order to allow the existing staff members the opportunity to meet with GSF prior to the board voting on the item. Mr. Provo stated these meetings have taken place and would like to move forward with the recommendation to award the bid. Ms. Sally Jones, GSF representative, was present to answer any questions from the board. There was some discussion with regards to the type of benefits the hired employees would have if they opted into those benefits. Mr. Perry McCubbins, Lead Mechanic/Grounds Director/Interim Maintenance Director spoke on outside maintenance, GSF cleaning of the outside areas after events, and the plans for setting up for graduation. Mr. Kizzee made a motion to approve the recommendation to award the bid to GSF Cleaning and Support Services. Mr. Kennedy seconded and the motion carried 4-0. Mr. Sears expressed his appreciation for GSF's follow up meetings with employees and their willingness to answer additional questions.

There were no final public comments.

**ADJOURNMENT**
