The BAC was established by the Board of Education prior to the November 6, 2012 passage of ballot measure 26-144 Portland Public School District Bonds to Improve Schools. The BAC is an independent group of board appointed community members charged with quarterly reviewing reports and annual audits of how the bond dollars are being spent to provide accountability to the public until construction is complete.
