### Board of Education Meeting Minutes ~ April 13, 2026

The Board of Education of School District 66 was convened in an open and public session on April 13, 2026, at 6:00 p.m. at the District Administration Office, 909 S. 76th St., Omaha, Nebraska.

Notice of the meeting was given by placing advance notice on the front page of the District's website no less than 48 hours in advance of the scheduled commencement of the meeting as authorized by Board Policy 1220. Notice for this meeting appeared beginning on March 24, 2026, and appeared continuously up through the start of this board meeting. All proceedings hereafter shown were taken while the convened meeting was open to the attendance of the public.

Mr. Yale called the Board of Education Meeting to order at 6:00 p.m. He welcomed those in attendance and confirmed that public notice had been given of the meeting under the Nebraska Open Meetings Act and that a copy of the Nebraska Open Meetings Act was posted at the meeting and on the district website, as required by law. He acknowledged that the meeting had been publicly announced and the agenda was available to any interested parties. Board Meeting attendance is noted above. The Pledge of Allegiance was recited.

#### **Approval of Minutes**

Mr. Yale requested a motion for approval of the minutes from the Board of Education Meeting held on March 23, 2026. Ms. Karnes moved for approval; Ms. Rider seconded. Motion carried by unanimous roll call vote.

#### **Communications**

Ms. Elizabeth Power, Director of Communications and Engagement, shared student, staff and community highlights, including: the Westside High School Concert Jazz Band received 1st Place and Best Overall Ratings at the 2026 State Jazz Festival and was also named Grand Champions for the fifth year in a row! WHS 2026 Prom Court candidates were announced this week; prom King and Queen will be announced at prom on Saturday, April 18th; the Oakdale and Sunset Hills Early Childhood programs were recognized by the NE Step Up to Quality program (<https://stepuptoquality.ne.gov/about/>); and despite a light spring snow shower, we had a great turn-out for the 'Golden W' meeting on April 7th at Westside Middle School!

### **Phase II Bond Project: Approval of Early Release Work Package for Loveland Elementary**

Mr. Matt Herzog, Project Advocates, requested approval of a contract amendment for early release work for the new Loveland Elementary School that will include site utilities, mechanical, electrical, plumbing, and fire suppression scopes of work. This approval will allow MCL Construction to facilitate coordination with precast shop drawings and installation of site utilities. The proposed Authorization value is \$7,859,686, which will be incorporated into the Guaranteed Maximum Price Amendment that will be presented to the Board of Education for approval on April 27, 2026. Ms. Blakely moved for approval; Ms. Rider seconded. Motion carried by unanimous roll call vote. Copies of the Executive Summary and contract amendment are included in the board documents folder.

### **Approval of Resolution - District General Obligation Bonds, Series 2019**

Dr. Van Gelder moved to adopt a Resolution of the Board of Education of Douglas County School District 0066 (Westside Community Schools) in the State of Nebraska authorizing the refunding and early redemption of a portion of the district's outstanding General Obligation Bonds, Series 2019, in such amounts and from such maturities as shall be determined by the authorized officials of the District; Ms. Morrisette seconded. Resolution was passed by a majority vote of the board; Ms. Karnes abstained. A copy of the resolution and bond document is included in the board document folder.

### **Approval of Resolution - District General Obligation Refunding Bonds, Series 2026B**

Ms. Morrisette moved to adopt a Resolution authorizing the issuance by Douglas County School District 0066 (Westside Community Schools) in the State of Nebraska of its General Obligation Refunding Bonds, Series 2026b, in an aggregate principal amount not to exceed two million seven hundred thousand dollars (\$2,700,000) for the purpose of refunding certain outstanding bonds of the District; prescribing the form and details of such bonds; authorizing certain officials to determine the final aggregate principal amount, maturities, rates, redemption provisions, terms and other details of such bonds; imposing an ad valorem tax on all taxable property within the district to pay the principal of, premium, if any, and the interest on such bonds; authorizing the designation of the bonds as qualified tax-exempt obligations, if applicable; authorizing the sale and delivery of the bonds to the purchaser thereof; authorizing certain actions and documents; and prescribing other matters relating thereto; Ms. Blakely seconded. Resolution was passed by a majority vote of the board; Ms. Karnes abstained. A copy of the resolution and bond document is included in the board document folder.

### **Board Policy for Approval - #5317**

Mr. Nick Lesiak, In-House Legal Counsel, presented one new policy for approval that was initially presented for board discussion and consideration on March 23, 2026.

#5317 - Enrollment of Expelled Students (Students) - This new policy outlines that a majority vote of the Board (as required by state statute) would be required to enroll any student during the term of any known expulsion of the student from any public or private school in any state. Ms. Karnes moved for approval; Ms. Rider seconded. Motion carried by unanimous roll call vote. Copies of the policy and Executive Summary are included in the board documents folder.

Ms. Rider moved for the Board to enter closed session to discuss a matter regarding student enrollment and to receive legal advice from the District's attorney, which is permitted by law and intended to protect the attorney-client privilege, to prevent the disclosure of personally identifiable information about a student, to prevent needless injury to a student's reputation, and because it is in the best interests of the student, other persons, and the school district to do so; Ms. Blakely seconded. Motion carried by unanimous roll call vote.

Mr. Yale restated that the Board has adopted a motion to enter closed session to discuss a matter regarding student enrollment and to receive legal advice from the District's attorney, which is permitted by law and intended to protect the attorney-client privilege, to prevent the disclosure of personally identifiable information about a student, to prevent needless injury to a student's reputation, and because it is in the best interests of the student, other persons, and the school district to do so. The Board will limit itself to discussion of these issues. The Board entered closed session at 6:26 p.m. At 6:47 p.m., the board came out of closed session. Ms. Karnes moved for the Board to approve the enrollment of the student as recommended by the administration on the condition that the student participates in an alternative school, class, or educational program pursuant to section [79-266](#) until the terms of the student's expulsion are completed; Ms. Rider seconded. Motion carried by unanimous roll call vote.

There being no further business, Mr. Yale adjourned the meeting at 6:48 p.m.

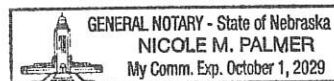
