Dr. Gina Kirchner, Director of Pupil Services, updated the Board on recent changes in attendance laws regarding defining, calculating, monitoring and reporting chronic absenteeism. Dr. Kirchner explained that the definition of chronic absenteeism, which is absenteeism greater than 10% of the time in school (approximately 18 days) used to exclude medical absences. Going forward, all absences are included in the calculation. Increased, new notification requirements to families were discussed. ODEW is releasing a new statewide attendance dashboard which will report attendance trends in public schools.


