Good Afternoon Board,

Since January, our Board has had ongoing discussions regarding E-Rate, fiber, and GadellNet for Aurora Academy, and we have now finalized the costs for approval. I am requesting an email vote to approve the E-Rate eligible infrastructure upgrades, as the final amount was not available at the time of our last discussion on April 6th.

These upgrades include the switches, access points, and installation services. After the 80% USAC subsidy, the total one-time cost to AACS is \$ 6,472.10, which will be invoiced in July.

Please note:

- This request is separate from the previously approved recurring cybersecurity services.
- This represents the AACS 20% share under the E-Rate program.
