## RFP 27-008 Security Services

### Addendum #3

**We are issuing this addendum to address the following:**

1. In Addendum #1, the response to Question 6 states that, the estimated total number of annual hours for this contract is based on 12 hours per day per guard over 187 calendar/school days per year per guard. The note below the pricing table in Section 11 states that the “school calendar consists of 180 instructional days.”
  - A. Is the total number of billable/school days based on 187 or 180 calendar/instructional days? Please clarify. **187 days**
  - B. The total number of armed and unarmed guards that are shown in the “Schedule of Charges” table in Section 11 is 46 (40 unarmed and 6 armed guards) which equates to a total of 99,360 hours per school year over 180 calendar/school days and 103,224 hours over 187 days. Which total should we use? **187 days**
2. When is the anticipated contract award date? **Anticipated to start August 1, 2026**
3. Is there an SRO assigned to each campus location full-time or do they rotate between campuses?  
**Full Time Officers Assigned to each campus**
4. RFP Section 6.1.8 states that, “The selected vendor must designate a field supervisor solely to handle STISD campuses for the daily inspections and must be available by phone at all times.”
  - A. Does each STISD campus require a field supervisor (FS) or does one field supervisor cover all campuses.
  - B. Is the Field Supervisor a billable position or is the cost for the FS included in the guard bill rate.  
**One field supervisor for all guards assigned to the district, with at least one Level 3 guard assigned to each campus. FS included in the guard bill rate.**
