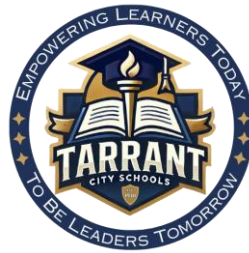


MEETING MINUTES
